CASES FILED WITH RECKLESS/CARELESS CHARGES IN CALENDAR YEAR 2021 STATEWIDE

September 27, 2022

Statistics Request Overall Description

On April 1, 2021, the University of Kentucky Transportation Center requested from Research and Statistics an update to four annual reckless/careless case reports for calendar year 2021. These reports include the total number of cases filed with one or more reckless/careless charges during calendar year 2021, the number of these cases filed and convicted within calendar year 2021, the number of these cases disposed in a manner other than conviction within calendar year 2021, and the number of these cases still pending as of December 31, 2021.

CourtNet, which provides a summary of cases statewide, was queried for cases including at least one reckless/careless charge filed from January 1, 2021 through December 31, 2021. The case was then evaluated per the disposition on the reckless/careless charge and categorized into the following categories:

- Cases that contain at least one convicted charge were categorized as *convicted*.
- Cases with pending reckless/careless charges, charges disposed later than 12/31/2021, or charges disposed as Failure to Appear (FTA) and Fugitive (FTV) were categorized as *pending*.
- Cases containing neither pending or convicted charges were categorized as *cases disposed in a manner other than conviction*.

A case may have multiple charges and each charge within a case may have different dispositions. This report categorizes the case in only one of the three categories.

Statistical Tables (22_RS3111)

Provides the total number of reckless/careless cases including at least one reckless/careless charge filed during CY 2021 in District Court including felony, misdemeanor, traffic and delinquency cases.

Page 1: provides a cross table of reckless/careless case counts and percentages of cases per the three categories:

- **Convicted:** The number of reckless/careless cases filed and convicted during calendar year 2021.
- **Disposed:** The number of reckless/careless cases disposed in a manner other than conviction during calendar year 2021. Failure to Appear (FTA) and Fugitive (FTV) are temporary dispositions and are not included in this total.
- **Pending as of 12/31/2021:** The number of reckless/careless cases still pending as of December 31, 2021.

Statistical Tables (22_RS3111)

A second cross table provides the total Reckless/Careless cases which have a reckless/careless offense closed with “FTA/FTV” charge disposition type.

Pages 2 through 9 provide a cross table of reckless/careless case counts and percentages grouped by the three categories sorted for each county.

Statistical Analysis Considerations:

- These statistics represent a snapshot in time as of the run date.
- Counts of cases count each case only once even though each case may include one or more reckless/careless charges.
- Counts of cases do not represent counts of individual defendants as the same defendant may appear in multiple cases.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
