Statistics Request Overall Description

On January 7, 2022, Research and Statistics received a request for a report containing the number of charges within Circuit Criminal cases disposed by jury trial from January 1, 2011, to December 31, 2021, in Anderson, Shelby, and Spencer counties.

The CourtNet database was queried for charges within Circuit Criminal cases disposed by jury trial from January 1, 2011, to December 31, 2021, in Anderson, Shelby, and Spencer counties (excluding charges of post-disposition offenses).

Statistical Report

Report 22_RS2001 provides the number of charges within Circuit Criminal cases disposed by jury trial from January 1, 2011, to December 31, 2021, in Anderson, Shelby, and Spencer counties (excluding charges of post-disposition offenses).

Statistical Analysis Considerations:

- The statistics provided are based on data collected from the CourtNet database.
- The statistics provided are a snapshot in time as of the date of the query.
- A case may consist of one or more charges. The count of cases presented herein represents a distinct count of case numbers, regardless of the number of charges associated with a case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case excluding post-disposition offenses (Contempt of Court, Probation Violation, or similar).
- Charges include ASCF Codes: 1 - Attempt, 2 - Solicitation, 3 - Conspiracy, 4 - Facilitation, 5 - Complicity, 6 - Enhancement.
