Statistics Request Overall Description

On March 8, 2024, Research and Statistics received a request from the Life Learning Center for a report of Specialty Courts/Drug Court Program participants entering and exiting the Specialty Courts program since January 1, 2023, in Boone, Campbell, and Kenton Counties, and a snapshot of active Participants as of the date of report.

The Specialty Courts Management Information System (AOC MIS), the case management and information system used by Specialty Courts, was queried multiple times as described below to collect the requested data:

- For Participants Entering the Adult Drug Court Program, a query for Participants in Boone, Campbell, and Kenton Counties in which the First Active Status date was between January 1, 2023 and March 27, 2024.
- For Participants Exiting the Adult Drug Court Program, a query for Participants in Boone, Campbell, and Kenton Counties in which the Exit Status date was between January 1, 2023 and March 27, 2024.
- For the snapshot of Currently Active Participants, a query for Participants in Boone, Campbell, and Kenton Counties was performed for Participants having:
 - a valid First Active Status date, and
 - no Exit Status Date or an Exit Status Date after the run date of the report
