DUI CHARGES WITHIN CASES FILED CALENDAR YEARS 2017 - 2021 IN JEFFERSON COUNTY

Statistics Request Overall Description

On February 17, 2022, WHAS requested a count of DUI charges within cases filed in Jefferson county for calendar years 2017 through 2021. A list of the specified charges queried for this report is attached.

CourtNet, which provides a summary of cases statewide, was queried for the DUI charges within cases filed in Jefferson county from January 1, 2017 through December 31, 2021.

Statistical Table (22_RS3027 & 22_RS3028)

Report 22_RS3028 *Supplemental Charge List* displays the requested DUI charges queried for this report.

22_RS3027 provides a count of DUI charges within cases filed in Jefferson county and is cross-tabulated by whether the charges were for Driving Under the Influence of Alcohol, Driving Under the Influence of Controlled Substances, or Driving Under the Influence of both alcohol and drugs.

Page 1: Provides counts of DUI charges within cases filed 2017 – 2021 in Circuit Court and in District Court in Jefferson County and is cross tabulated by the year the charge was filed.

Page 2: Provides counts of DUI charges within cases filed 2017 – 2021 in Circuit Court in Jefferson County and is cross tabulated by the year the charge was filed as well as the UOR charge and description.

Page 3: Provides counts of DUI charges within cases filed in 2017 in District Court in Jefferson County and is cross tabulated by the year the charge was filed as well as the UOR charge and description.

Page 4: Provides counts of DUI charges within cases filed in 2018 in District Court in Jefferson County and is cross tabulated by the year the charge was filed as well as the UOR charge and description.

Page 5: Provides counts of DUI charges within cases filed in 2019 in District Court in Jefferson County and is cross tabulated by the year the charge was filed as well as the UOR charge and description.

Page 8 and 9: Provide counts of DUI charges within cases filed in 2021 in District Court in Jefferson County and is cross tabulated by the year the charge was filed as well as the UOR charge and description.

Statistical Analysis Considerations:

- These statistics represent a snapshot in time, as of February 18, 2022.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case.
- Charges include ASCF Codes: 1 - Attempt, 2 - Solicitation, 3 - Conspiracy, 4 - Facilitation, 5 - Complicity, 6 - Enhancement.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
