Statistics Request Overall Description

On February 2, 2022, Research and Statistics received a request for a report of the number of convictions and the number of indictments for CY 17 – CY 21 in Franklin county.

CourtNet, which provides a summary of cases statewide, was queried for drug charges disposed CY 2017 through CY 2021 (January 1, 2017 to December 31, 2021) in Franklin county. The case types included are Circuit Criminal, Felony and Misdemeanor cases. Excludes appeal and Juvenile¹ delinquency cases.

Statistical Report (22_RS3024)

Statistical report 22_RS3024 consists of twelve (12) pages that provide drug charges disposed during the requested timeframe for Franklin county.

Page 1: A line graph providing the count of drug charges disposed within criminal cases by year of the charge disposition, case category and jurisdiction.

Page 2: A vertical bar graph providing the total count of drug charges within criminal cases per CY, within by year the of the charge disposition and jurisdiction, along with the distinct count of cases per year.

Pages 3-7: A series of tables providing counts of charges disposed within **Circuit criminal** cases, along with the distinct count of cases. Each table is grouped by charge disposition type category, charge disposition and AOC Offense Group. A separate table is provided for each of the calendar years requested (CY 2017 – CY 2021).

Pages 8: A summary table for calendar years (CY 2017 – CY 2021) providing counts of charges disposed within **Circuit criminal** cases, along with the distinct count of cases, grouped by charge disposition type category, charge disposition and AOC Offense Group.

Pages 9-13: A series of tables providing counts of charges disposed within **District criminal (Felony & Misdemeanor)**, along with the distinct count of cases. Each table is grouped by charge disposition

Statistical Analysis Considerations:

- The data presented is a snapshot in time as of February 12, 2022.
- Counts of cases should not be considered counts of individuals, as some individuals could be involved with multiple filed cases.
- A case may consist of one or multiple charges. The report’s count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Charges included in this report include ASCF Codes (1-Attempt, 2-Solicitation, 3-Conspiracy, 4-Facilitation, 5-Complicity, 6-Enhancement); however, only the base charge description is displayed for grouping purposes.

ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

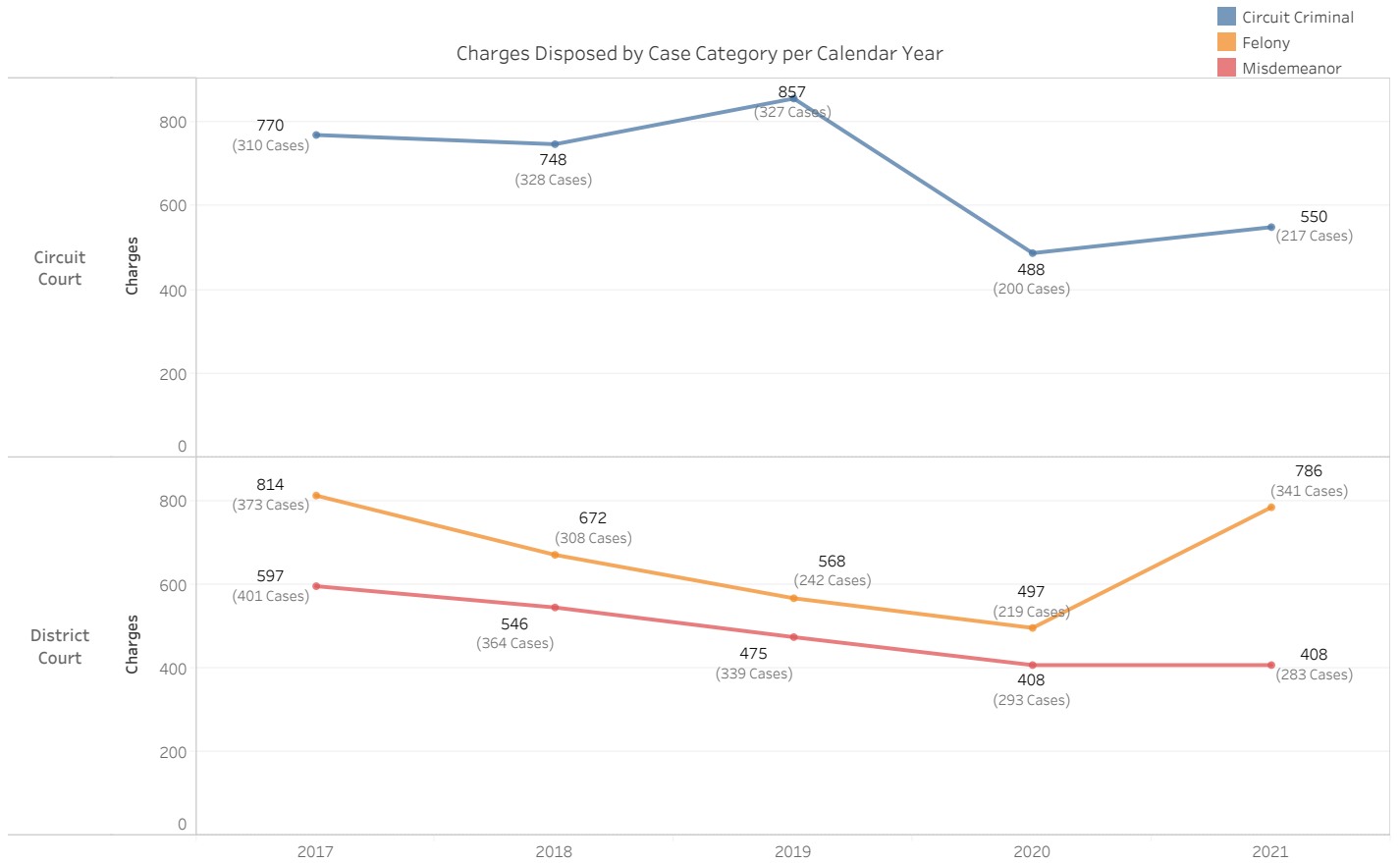

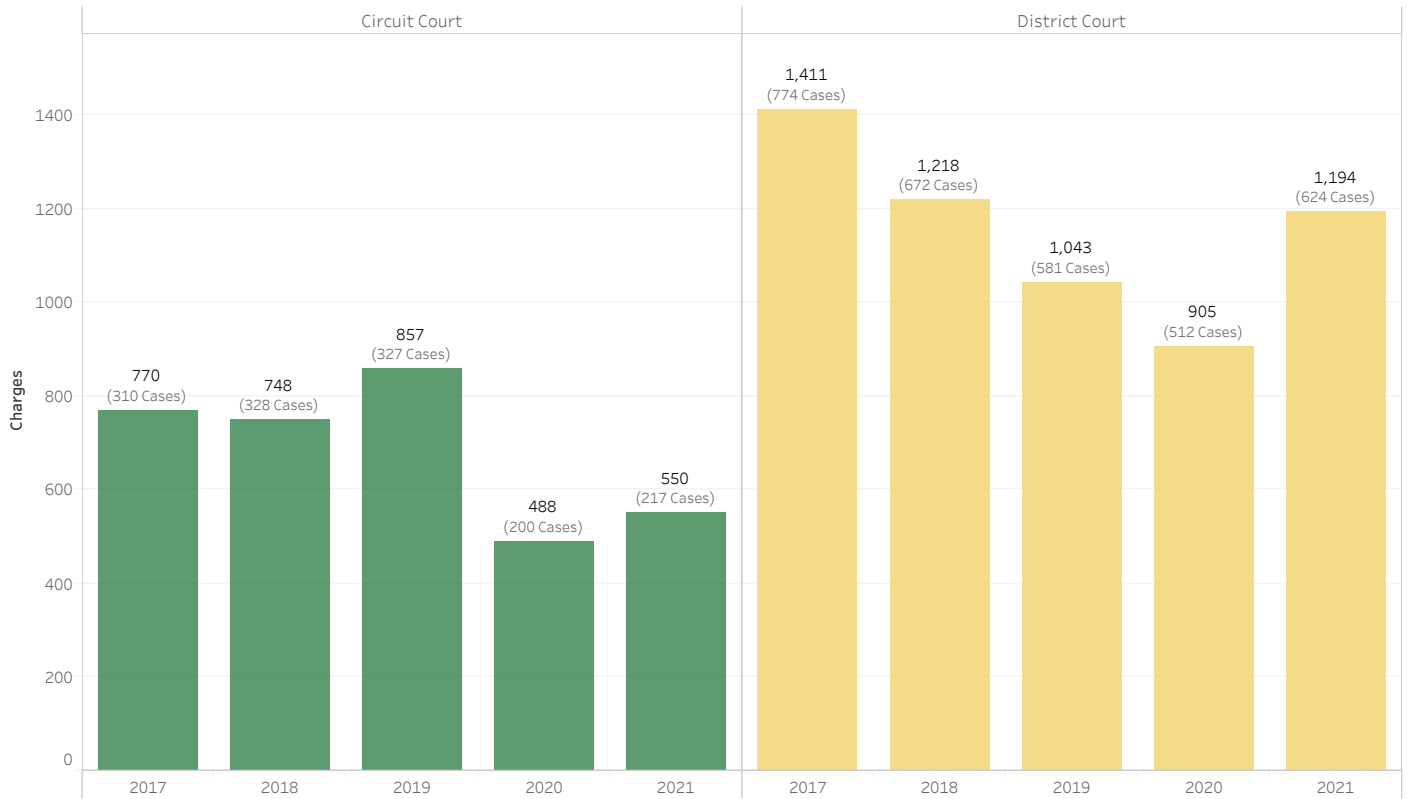
