Statistics Request Overall Description

On July 19, 2024, Research and Statistics received a request for an aggregate report of animal cruelty charges filed and disposed statewide from calendar year (CY) 2003 through calendar year 2023. It was also requested that information on the race of defendants of these charges be provided, as well as sentencing information.

CourtNet, which provides a summary of cases statewide, was queried for charges with an AOC Offense Category of *Animal Abuse* that were either within cases filed from 1/1/2003 through 12/31/2023 or were disposed during that time frame. The offenses included in this report are provided in a supplemental UOR list.

Sentence information is provided for each of the convicted charges. The sentence information only represents individual charge sentence information and does not provide the overall punishment for cases or individuals.

Sentencing Information

Sentence entries for each charge may consist of the Sentence Imposed, along with any amount probated, suspended, and/or conditionally discharged, and/or sentenced to home incarceration.

Convictions of sentences with incarceration may be fully or partially suspended. When the total amount of sentence modifications is equal to the sentenced imposed, the sentence may be considered fully suspended.

The amount of incarceration time sentenced is indicated as JORP (Jail or Prison). There are additional check boxes available to specifically indicate Jail and Prison, but these are not required, may not be used consistently, and no logical constraints restrict the use of these check boxes to given amounts of incarceration time sentenced. Some prison incarceration sentences of greater than a year may be served in county jails.

Factors which affect the overall remaining sentence:

- When multiple sentences of imprisonment are imposed on a defendant for more than one (1) crime, the multiple sentence time intervals can be ordered to run concurrently or consecutively as

determined by the court at the time of sentence. The concurrent/consecutive indicator does not distinguish the charge(s) or case(s) the sentence was ordered to be concurrent / consecutive with.

- a. Concurrent Sentence: A sentence for a conviction that a court orders a defendant to serve simultaneously with the defendant's sentence for a different conviction. A sentence may be fully or partially concurrent.
 - b. Consecutive Sentence: A sentence for a conviction that a court orders a defendant to serve only after he has discharged a sentence for a different conviction. A sentence may be fully or partially consecutive.
- There are additional checkboxes to capture conditional discharge time. These checkboxes are not taken into consideration within this report. These charges may be reported in the "other penalty" category.
 - Probation violations involve conduct that violates any judicial order imposing supervision of a defendant. Violations of probation and supervised release may result in "Probation Revocation" which is the annulment, cancellation, or reversal of an act, with regard to probation or supervised release, the term generally refers to the judicial act of canceling the supervision in response to the offender violation the terms of supervision and impose a term of incarceration.
 - Shock probation is a form of conditional early release from prison (before the full term of imprisonment expires). Upon violation of a parole condition, a parolee may be placed back in prison to complete the remainder of the sentence. (KRS 439.265)
 - Set Aside/Vacated Sentence When a sentence for one or more charges is set aside or vacated, the sentence information is removed and can no longer be reported.
 - Expungement of Conviction When one or more charges within a case is granted expungement, it can no longer be reported as the sentence information for these charges is removed as part of the expungement process.

Statistical Report (24_RS6054)

This report provides 80 pages of data aggregations displaying counts of specified charges that were either within cases filed from 1/1/2003 through 12/31/2023 or were disposed during that time frame.

Pages 1-2 provide a table containing the UOR codes that were queried for the report. The Kentucky Revised Statute, Offense Description, UOR Add Date, UOR Obsolete date, and Charge Level and Class are provided for each code.

Pages 3-6 provide a cross-tabulation that displays counts of specified charges within cases filed in Circuit Court between 1/1/2003 and 12/31/2023. These counts are broken down by Case Filing Year, Race of Defendant, and UOR Code and Description. Additionally, counts of distinct cases that contain these charges are provided.

Pages 7-9 provide the same information as pages 3-6, but for cases filed in District Court.

Pages 10-38 provide a cross-tabulation that displays counts of specified charges disposed in Circuit Court between 1/1/2003 and 12/31/2023. These counts are broken down by Disposition Category, Charge Disposition Year, Race of Defendant, and UOR Code and Description. Additionally, counts of distinct cases that contain these charges are provided.

Pages 39-77 provide the same information as pages 10-38, but for cases filed in District Court.

Page 78 provides a cross-tabulation with counts of charges that were convicted between 1/1/2003 and 12/31/2023, grouped by jurisdiction and most serious penalty type associated with a charge. Additionally, the percent of charges with a given highest penalty type and the count of distinct cases containing those charges is provided. A sentence can have more than one penalty, this page provides charges by the first penalty criterion satisfied in the hierarchy as follows:

- Incarcerated Prison
- Incarcerated Jail
- Alternative Home Incarceration
- Alternative Conditionally Discharged
- Pay Fine
- Pay Court Cost
- No Sentence
- Alternative/Other Penalty

Note: Probation information is not reportable, cases which have probation may fall into the Alternative/Other Penalty category.

Page 79 provides a cross-tabulation with counts of charges that were convicted between 1/1/2003 and 12/31/2023, grouped by jurisdiction, alternative sentence penalty type, and the following conditions:

- Alcohol/Drug Education
- Traffic School
- Community Service Imposed
- Restitution
- Undergo Treatment
- CPD Other (Conditionally Probated or Discharged)
- Sentence Other
- Remain in Area
- Report to Probation Officer
- Notify Probation Officer
- Permit Probation Officer Visit

Note: Charges may be given multiple conditions. The same charge may be counted in multiple alternative sentence and condition categories.

Page 80 provides a cross-tabulation with counts of charges that were convicted between 1/1/2003 and 12/31/2023 and had a fine imposed as part of a sentence, grouped by jurisdiction and fine status. Fine statuses are as follows:

- a. Charges with a fine amount imposed, *partially* suspended, or conditionally discharged.
- b. Charges with a fine amount imposed, *not* suspended, probated, or conditionally discharged.
- c. Charges with a fine amount imposed, *totally* suspended, probated, or conditionally discharged.

Statistical Analysis Considerations:

- These statistics represent a snapshot in time as of the date the data was queried (8/27/2024).
- The sentence information in this report represents only the sentence ordered for that *charge* and does not provide the overall punishment for cases or individuals.
- Sentence time entered represents the sentence ordered by the court. Subsequent modifications by the Department of Corrections to the length of incarceration is not reflected in this report.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges within the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Many, but not all, charges heard in Circuit Court were previously heard in District Court and indicted by the grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.
- Most indicted charges are recorded in CourtNet as final charge dispositions in District Court and then a new case will be started in Circuit Court. Not all indictments are followed by convictions in Circuit Court, and some charges are indicted directly to Circuit Court without being preceded by a District Felony case.
- Some UOR Codes queried for this report were introduced or made obsolete during the requested date range or were introduced after the end of the requested date range.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at <https://kycourts.gov/AOC/Information-and-Technology/Analytics/Pages/default.aspx>. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. The first six digits are specific to that charge. The seventh digit indicates if there

is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
