Statistics Request Overall Description

On October 20, 2022, WLEX News requested a report with the release and decision outcome for juvenile offenders to include the type of offense, during a specified timeframe CY 2019 through year-to-date CY 2022 for the following:

- The number of juveniles charged with gun-possession
- The charges that went along with their gun possession charge
- Has this number changed significantly over time or not at all
- The ages of youth, along with the youngest age
- The race of the youth (what role does race play in representation of charges)

Complaints were compiled from AOC CDWCMS, the case management and information system used by AOC Court Designated Workers (CDW), limited to complaints filed with the specified offenses of possession of gun (see supplemental list below) from January 1, 2015 through November 16, 2022. The statistics are sorted by the specific counties of Fayette and Jefferson, then the remaining counties Statewide.

Statistical Tables (22_CDW3199)

Statistical Report 22_CDW3199 provides complaints filed during 1/1/2015 – 11/16/2022 and provides statistical counts for each Jefferson, Fayette and Statewide (remaining counties).

Page 1: Provides a line chart of gun possession charges within complaints filed per CY represented as a separate line of a differing color for Jefferson, Fayette and Statewide (remaining counties). The cross table provides those counts of charges, along with the distinct count of complaints and youth per CY.

- **Page 2:** Provides a horizontal stacked bar chart with percentage of complaints for Jefferson, Fayette and Statewide (remaining counties) represented as a differing color. The cross table provides those counts of complaints, percentages and the distinct count of youth per CY.
- **Page 3:** Provides a horizontal stacked bar chart with the percentage of complaints by intake action group (Extension of Detention, Child Released by Peace Officer, Child Released by CDW, Child not taken into Custody) represented as a differing color.
- **Page 4:** The cross table provides the distinct count of complaints and percentage of complaints per CY by intake action group.

Page 5: Provides a horizontal stacked bar chart with the percentage of complaints by charge close reason group (Formal Court Referral, Dismissed (Other), Dismissed (Successful Diversion), Other & Open) represented as a differing color. The cross table provides the distinct count of complaints by charge close reason group and charge close reason.

Page 6: Provides a cross table of the gun possession charges within complaints filed by Offense Description along with the distinct count of complaints and youth.

Page 7: Provides a vertical bar chart with the percentage of youth by race (Hispanic, White, Black, Other & Unknown) represented as a differing color.

Page 8: Provides a cross table of the count of youth by age at the complaint filing date. The youngest in Fayette was 13 years of age, in Jefferson was 11 years of age and in the remaining counties was 6 years of age at complaint filing.

Page 9: Provides a horizontal bar chart representing the counts of charges for the other offenses within the complaints with possession of gun, ranked by AOC Offense Category by highest to least of the charges utilized within the group.

Complaint County	Indicates the county where the complaint was filed. Counts are provided for Fayette County, Jefferson County and Statewide (excluding Fayette & Jefferson) which counts the 118 counties other than Fayette & Jefferson.
Complaint Filing Date	The date the complaint was signed by the affiant, the individual filing the complaint.
Intake Action	Indicates whether the youth was taken into custody; if so, whether the youth was released or detained, and if released, by whom. The intake actions include: • Child taken into Custody • Released by CDW or peace officer • Extension of Detention
Intake Action Result	 Released – the intake actions where the child is released back into the community: child not taken into custody, child released by peace officer, child released by CDW Detained – the intake action where the child is placed in secure detention: extension of detention
Charge Description	A field which displays the name of the charge filed against a youth.
AOC Offense Category	Similar offenses are grouped into AOC Offense Category for reporting purposes. The category included in this report are gun related offenses. A list of the codes is located below.
Race/Ethnicity	The self-reported race and ethnicity of the youth. For the purposes of this report, the race has been aggregated into four categories: • Hispanic • Non-Hispanic African American • Non-Hispanic Caucasian • Non-Hispanic Other
Youth Age at Complaint Filing	The age of the youth at the time of complaint filings, calculated by dividing the difference between the complaint filing date and the child's birth date by the number of days in a year and rounding down.
Specified Charges	A selection of offenses identified by the requestor. The full table of offenses included is located at the end of this methodology.


A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.








