### **Statistics Request Overall Description**

Research and Statistics received a request for the number of *Verified Petition for Involuntary Treatment (PIHAD)* and *Judgment and Order for Involuntary Treatment (JOIT)* documents entered in mental health cases since the implementation of Casey's Law in 2004 (January 1, 2004, to December 31, 2021) statewide.

CourtNet, which provides a summary of cases statewide, was queried for document types *PIHAD* and *JOIT* entered statewide in mental health cases from January 1, 2004, to December 31, 2021.
