## **Statistics Request Overall Description**

On August 26, 2022, Research and Statistics received a request for a report of the number of *Verified Petition for Involuntary Treatment (PIHAD)* and *Judgment and Order for Involuntary Treatment (JOIT)* documents entered in mental health cases from January 1, 2004, to July 31, 2022, statewide since the implementation of Casey's Law in 2004.

CourtNet, which provides a summary of cases statewide, was queried for document types *PIHAD* and *JOIT* entered in mental health cases from January 1, 2004, to July 31, 2022, statewide since the implementation of Casey's Law in 2004.
