CRIMINAL CHARGES WITHIN CASES FILED CALENDAR YEAR 2022 BY DISPOSITION CATEGORY IN CARROLL, GRANT, AND OWEN COUNTIES

July 20, 2023

Statistics Request Overall Description

On June 15, 2023, the Commonwealth's Attorney for the 15th Circuit requested from Research and Statistics a report of cases filed in calendar year 2022 with charge disposition type for Carroll, Grant, and Owen counties.

CourtNet, which provides a summary of cases statewide, was queried for Circuit Criminal (CR), Felony (F), Misdemeanor(M) and Traffic (T) cases filed January 1, 2022 through December 31, 2022 by disposition type and by AOC Offense Category. The offenses within the following AOC Offense Categories have been excluded: Added (ADD), Created for Administrative Purposes (ADM), and Related to Custody (RTC).

Statistical Tables (23_RS3003) & 23_RS4007)

Report 23_RS3003 provides cases filed during calendar year 2022 in Carroll, Grant, and Owen counties sorted by charge level and class, AOC Offense Category and disposition category. The offenses within the following AOC Offense Categories have been excluded: Added (ADD), Created for Administrative Purposes (ADM), and Related to Custody (RTC).

A report is provided for each county with pages numbered as follows:

Page 1: A summary of charges within cases filed in Circuit Court by case number type and disposition category.

Page 2: A summary of charges within cases filed in District Court by case number type and disposition category.

Page 3: Felony B and C charges filed in Circuit Court by disposition and AOC Offense Category.

Page 4: Felony D and Felony X charges filed in Circuit Court by disposition and AOC Offense Category.

Page 5: Felony B and C charges filed in District Court by disposition and AOC Offense Category.

Page 6: Felony D charges filed in District Court by disposition and AOC Offense Category.

Pages 7 & 8: Misdemeanor A charges filed in District Court by disposition and AOC Offense Category. **Page 9 & 10:** Misdemeanor B charges filed in District Court by disposition and AOC Offense Category.

Report 23_RS4007 is a list of the AOC Offense Categories is provided. AOC Offense Categories were created by Research and Statistics to identify related offenses for statistical reporting purposes.

Statistical Analysis Considerations:

- > The statistics presented are a snapshot in time, as of the date the data was queried: 7/20/23.
- The report's count of cases represents a distinct count of case numbers. Counts of cases do not necessarily represent counts of unique individuals. An individual can have multiple cases.
- Charges consist of all original and amended charges within a case. The offenses within the following AOC Offense Categories have been excluded: Added (ADD), Created for Administrative Purposes (ADM), and Related to Custody (RTC).
- Many, but not all, charges heard in Circuit Court were previously heard in District Court and indicted by the grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.
- Most indicted charges are recorded in CourtNet as final charge dispositions in District Court and then a new case will be started in Circuit Court. Not all indictments are followed by convictions in Circuit Court, and some charges are indicted directly to Circuit Court without being preceded by a District Felony case.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at <u>https://kycourts.gov/AOC/Information-and-Technology/Analytics/Pages/default.aspx</u>. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
