Statistics Request Overall Description

On February 28, 2021, the Kentucky Center for Economic Policy requested from Research and Statistics a report of Circuit Criminal cases filed during Calendar Year (CY) 2020 to 2021 by the class of the most serious charge in each case, reporting statewide and Campbell, Fayette, Hardin, Kenton, Madison, Pulaski, and Warren Counties. Along with the number of such criminal cases with charges as indicated below:

- Including at least one charge of a Class D Felony Possession of Controlled Substance offense and no charges of felonies outside of this category,
- Including at least one charge of a set of specified Class D Felony Theft by Unlawful Taking or Receiving Stolen Property offenses and no charges of felonies outside of this category,
- Including at least one charge of Flagrant Non-Support and no charges of other felony offenses.

CourtNet, which provides a summary of cases statewide, was queried for Circuit Criminal cases filed CY 2020-2021 along with any felony charges. Cases were flagged as members of the categories described above if they included at least one charge of a Felony D offense corresponding to the data definition below and no charges of felony level offenses outside of the definition:

- Possession of Controlled Substance: AOC Offense Category Possession of Controlled Substance
- Theft by Unlawful Taking / Receiving Stolen Property: KRS 514.030 (excluding firearms and anhydrous ammonia), 514.040, 514.050, 514.060, 514.070, or 514.090; or UOR codes 024060, 028030, or 023235.
- Flagrant Non-Support: UOR Code 038010

A list of applicable UOR codes is included with this report.

Statistical Report (20_RS8021)

The one-page layout in this report is repeated eight times. The first page includes statewide data and the following pages include cases filed in Campbell, Fayette, Hardin, Kenton, Pulaski, Madison, and Warren Counties respectively.

Each report begins with a summary of all Circuit Criminal cases filed during CY 20-21 grouped by the class of the most serious charge in each case. A bar chart presents the quantity of cases filed each year with the Felony class of the most serious charge indicated by color. A cross-tabulation then

presents the number of cases grouped by year of case filing and class of the most serious charge in each case, as well as the percentage by most serious charge class for each year of case filing.

The lower section of each page presents the cases filed each year in which the most serious charge in each case was a Class D felony grouped by Charge Category, indicating cases meeting each of the three categories described above or categorized as "Others". A bar chart presents the quantity of these cases filed each year with the category indicated by color. A cross-tabulation follows, presenting the number of such cases grouped by year of case filing and Charge Category, as well as the percentage of each charge category within each year of case filing.

Statistical Analysis Considerations:

- \triangleright This report represents a snapshot in time as of the date of the guery (3/10/2022).
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- > Counts of cases do not necessarily represent counts of unique individuals.
- > Charges consist of all original and amended charges within a case.

RESEARCH AND STATISTICS UOR CODE DISCLAIMER

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code.

However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
