### **Statistics Request Overall Description**

On April 4, 2023, the Office of the Jefferson County Public Defender requested from Research and Statistics Circuit Criminal cases filed in Jefferson County for CY 2019 through present day by trial type.

CourtNet, which provides a summary of cases statewide, was queried for Circuit Criminal (CR) cases filed in Jefferson County from 1/1/2019 through 4/11/2023 by charge disposition manner (trial type).

### Statistical Table (23\_RS3051)

**Report 23\_RS3051** provides cases filed during timeframe 1/1/2019 - 4/11/23 in Jefferson County sorted by Case Number Type, Case Category and the Type of Trial based on the charge disposition manner. Disposition Manner is entered independently for each criminal charge, the trial type is determined in the following order: Jury Trial, Court Trial, No Trial, and Unknown Trial.
