### Statistics Request Overall Description

On February 18, 2026, Research and Statistics received a request from the Center for Investigative Reporting for a report of the number of concealing birth of an infant charges within cases filed in all counties statewide for calendar years from July 1, 2002 to 2026 year to date.

CourtNet, which provides a summary of cases statewide, was queried for the specified charges filed in Circuit and District Courts for all counties Statewide from July 1, 2002, to February 18, 2026. A charge list of the specified offense by UOR code is included in this report.

### Statistical Report (21\_RSX9000, 21\_RSX9001)

**21\_RSX9000** provides a list of charges which were queried for the report, grouped by related KRS Chapter and Section, UOR Code, UOR Description, and Charge Level and Class.

**21\_RSX9001** provides a crosstab with counts of the specified charges within cases filed in Circuit Court during CY02 and CY26 in all counties statewide grouped by county, UOR code, and description. Additionally, a count of distinct cases containing those charges is provided.

**Pages 1-5:** Provide a cross-tabulation that displays counts of the specified charges filed in Circuit Court and District Court grouped by UOR code and case filing year.

**Page 6 and 7:** Provide the summarized totals for Circuit and District Court from pages 1-5.

#### Statistical Analysis Considerations:

- These statistics represent a snapshot in time as of the date the data was queried: February 18, 2026.
- A case may consist of one or more charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of any original or amended charges within a case.
- Many but not all charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
