### Statistics Request Overall Description

On October 18, 2025, Research and Statistics received a request for a report of Domestic Violence charges disposed since January 1, 2020 in Boyle County.

The CourtNet database, which provides a summary of cases statewide, was queried for the specified charges disposed from January 1, 2020, through November 11, 2025, in Boyle County.

### Statistical Report

The report includes a list of the specific offenses queried for the report followed by 20 pages of tabulated counts of these charges disposed between January 1, 2020 and November 11, 2025 in Boyle County.

**Pages 1-14** provide a pair of cross-tabulations of specified charges disposed by Charge Disposition Year, County, UOR Code, and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided. The first of these tables (Pages 1-6) includes Circuit Court dispositions and the second of these tables (Pages 8-14) includes District Court dispositions.

**Pages 15-19** provide a pair of cross-tabulations of specified charges disposed by UOR Code and Charge Disposition Category. Counts are provided for the requested timeframe with counts of distinct cases containing those charges. The first of these tables (Pages 15-16) includes Circuit Court dispositions and the second of these tables (Pages 17-19) includes District Court dispositions.

**Page 20** provides a cross-tabulation of specified charges disposed by Jurisdiction and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided.

#### Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 11/12/2025.

### Statistical Report

- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case counted separately.
- Many but not all charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately. Some UOR codes queried for this report leave the age of the victim ambiguous or unspecified.
