



## COMPLAINTS CLOSED WITH FAIR REFERRALS YOUTH INDICATING 504 PLAN OR IEP CY 2015-2021

### Statistics Request Overall Description

On October 18, 2022, Research & Statistics received a request for a report of complaints closed calendar years (CY) 2015 through 2021 with FAIR Referral, including 504 Plan and IEP information as indicated by the Youth during the Preliminary Inquiry process.

Complaints were compiled from AOC CDWCMS, the case management and information system used by AOC Court Designated Workers (CDW), and this data was filtered to include complaints closed during calendar years 2015 through 2021 with FAIR referral.

### Statistical Report (22\_CDW7015)

The report consists of one page.

**Table 1:** This table displays a count of Distinct Youth and Complaints closed between January 1, 2015, and December 31, 2022, having a FAIR Referral. It is grouped by the Youth indicated during the Preliminary Inquiry that they had a 504 Plan, an IEP or neither. It is sorted by CY of the complaint close date.

### Statistical Analysis Considerations

- The statistical information presented is a snapshot in time as of October 31, 2022.
- Counts of complaints do not equal a count of youth, since a youth may have multiple complaints.

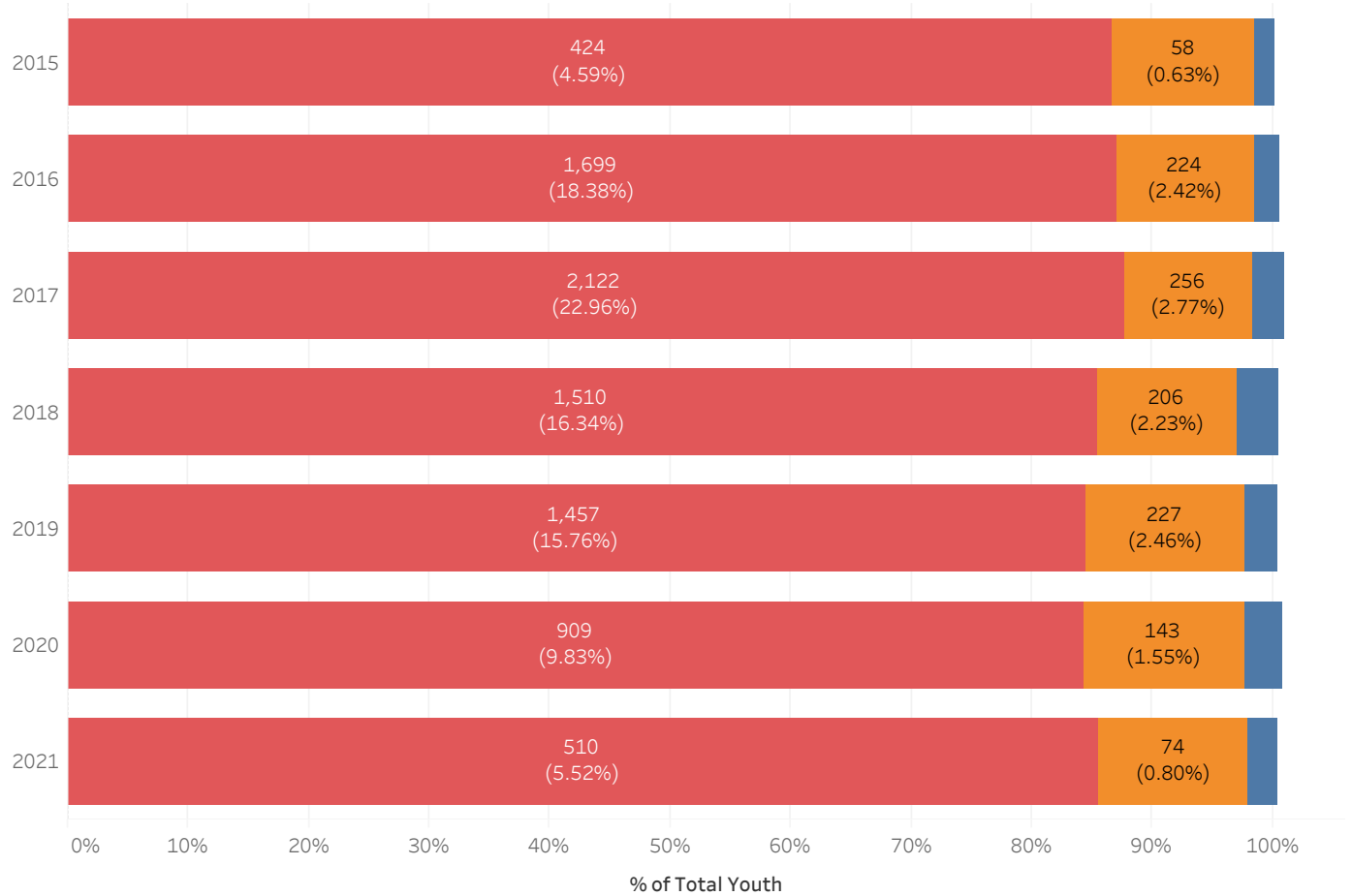
