FORCIBLE DETAINER CASES FILED CY 2019 - 2021 FAYETTE COUNTY

July 15, 2022

Statistics Request Overall Description

On June 8, 2022, Research and Statistics received a request for a report of the number of Forcible Detainer cases filed in Fayette County during Calendar Years (CY) 2019-2021 and the status of these cases.

CourtNet, which provides a summary of cases statewide, was queried for District Civil (Case Number Type *C*) cases with the Forcible Detainer (*FD*) Case Type Code filed from January 1, 2019, through December 31, 2021 in Fayette County. and for the presence of documents with the document codes listed below related to these cases.

Document Code	Description
EW	Eviction Notice: Warrant for Possession
NE	Eviction Notice: Notice of Eviction Hearing
FDVOC	Verification of Compliance with CARES Act
JDF	Judgment For Defendant in Forcible Entry & Detainer - Not Guilty
JPF	Judgment For Plaintiff in Forcible Entry & Detainer - Guilty

No cases filed during the requested date range included the **NE** document.

Please note the presence of document **JDF** indicates that the court found in favor of the defendant within an FD case, while the presence of document **JPF** indicates that the court found in favor of the plaintiff within an FD case. It is possible for a single case to include more than one of either document or a mixture of both documents, though this is rare. This typically occurs in cases with multiple defendants or represents data entry error.

The presence of one or more of the following document codes (**EW**, **NE** or **FDVOC**) within an FD case does not necessarily determine the court's ruling in favor of either party. The presence of these document codes indicates the filing of the document within the case and does not represent the actual process of eviction.

The Eviction Notice: Notice of Eviction Hearing (EN) is filed by the landlord against the tenant claiming the tenant is not entitled to remain on the premises.

The Eviction Notice: Warrant for Possession (**EW**) is filed against a tenant who was found guilty of forcible detainer at the hearing and tenant has not timely filed an appeal of the judgment of forcible detainer.

Statistics Request Overall Description

The Verification of Compliance with CARES Act: (**FDVOC**) is a separate document that is to accompany any eviction filings verifying that the eviction is not prohibited under the CARES Act regarding the COVID-19 Federal Eviction Moratorium.

- The CARES Act eviction moratorium began on March 27, 2020, and ended on July 24, 2020. Covered tenants could not be forced to vacate, and landlords could not file notices to vacate, until 30 days after the expiration of the moratorium (August 23, 2020).
- The CDC eviction moratorium took effect September 4, 2020, and was initially slated to
 extend through December 31, 2020. However, it was extended legislatively through January
 31, 2021, and extended again by CDC through March 31, 2021. On March 29, 2021, CDC
 further extended the moratorium until June 30, 2021. The CDC moratorium does not address
 notices to vacate.

Statistical Report (22 RS8012)

The data has been compiled into three pages.

Page 1: A bar chart presents a visualization of the number of cases filed each month along with the proportion having a status of Pending, Disposed with a Judgment for Plaintiff and/or Eviction Warrant, or Disposed without either of these documents. Please note that this is not an official status but was created for the purpose of succinctly summarizing the rest of the data presented later in the report.

Page 2: This table presents the number of cases filed in each year and month of the requested date range. It includes the total number of cases and separate counts of cases including at least one of each of the specified documents. These counts are not mutually exclusive since a case may have combinations of more than one of the indicated types of documents.

For example, the document code **FDVOC** has a result of 0 for each month until March, 2020. This means that none of these documents were entered within a Fayette County FD case that was filed prior to March 2020, but only entered in cases that were filed in later months.

Page 3: This table presents the number of cases filed in each year and month of the requested timeframe, grouped by Case Disposition. Each case may only have a single Case Disposition Type Code, and as such the reported dispositions are mutually exclusive.

Statistical Analysis Considerations:

- > The statistics presented in the attached tables are a snapshot in time as of the date the data was queried: July 15, 2022.
- A single case may contain more than one of the specified types of document. This report includes only counts of distinct cases.

	Case Disposition	An indication of the nature of the disposition of the case as determined by the case disposition code. Each case may have only one disposition code. Pending cases are identified by the absence of this code.						
	Eviction Notice	An indicator that notes the presence or absence of the document NE (Notice of Eviction) in a case.						
	Eviction Warrant	An indicator that notes the presence or absence of the document EW (Eviction Warrant) in a case.						
	FDVOC	An indicator that notes the presence or absence of the document FDVOC (Verification of Compliance with CARES Act) in a case.
