# AMENDED INFORMATION ON SPECIFIED FELONY SEXUAL ASSAULT CHARGES DISPOSED 1/1/2018-12/31/2022, STATEWIDE

## Statistics Request Overall Description

On August 11, 2023, Research and Statistics received a request for specific felony sexual assault charges amended, original crime vs. amended offense. The purpose of this request is to look for trends in plea bargaining of sex crimes.

CourtNet, which provides a summary of cases, was queried for specified original felony sexual assault offenses amended during 1/1/2018 - 12/31/2022 and the final amended offense, statewide.

A list of the specific felony sexual assault charges requested for this report are provided on a supplemental offense list.

## Statistical Report (23\_RS3083)

This report provides three (3) tables grouped by court jurisdiction. Circuit Criminal cases, District Felony cases, and Juvenile Delinquency cases, statewide. The tables include a count of charges and a distinct count of cases per each original amended felony sexual offense grouped the AOC Offense Category, charge description, charge disposition group of the final amended offense.

**Circuit Criminal Table (pages 1-13):** This table provides the amended information for the original specified felony sexual assault charges within Circuit Criminal (CR) cases that were amended during the timeframe.

**District Felony Table (pages 14-17):** This table provides the amended information for the original specified felony sexual assault charges within District Felony (F) cases that were amended during the timeframe.

**Juvenile Delinquency Table (pages 18-21):** This table provides the amended information for the original specified felony sexual assault charges within Juvenile Delinquency (J) cases that were amended during the timeframe.

Statistical Analysis Considerations:

These statistics represent a snapshot in time from the date the report was queried: 11/8/2023.

## Statistical Report (23\_RS3083)

- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case. Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case and include ASCF Codes: 1
   Attempt, 2 Solicitation, 3 Conspiracy, 4 Facilitation, 5 Complicity, 6 Enhancement.
