FRANKLIN COUNTY PRIM DRUG TEST EVENTS CY 2017-2022

Statistics Request Overall Description

On February 2, 2022, Research and Statistics received a request for a report of the number of Pretrial Drug Tests conducted in Franklin County during Calendar Years (CY) 2017 through 2022.

PRIM, the information system used by Pretrial Services, was queried for Drug Test Events with event dates from 1/1/2017 through 12/31/2022 in which Franklin County is indicated as the event county. The query included identifiers for related court cases, pretrial interviews, and distinct defendants.

Statistical Report (22_PINS8005)

The report consists of a line graph and a table. The line graph depicts the number of Franklin County drug tests for each CY 2017-2022 as tracked in PRIM. The table include the distinct number of drug tests, related court cases, related pretrial interviews, and unique defendants for each CY of drug test dates.

Statistical Analysis Considerations:

- > The statistics presented in the attached tables are a snapshot in time as of the date the data was queried: 2/15/2022.
- > A single defendant may be involved in multiple pretrial interviews during a given period of time.
- > Each interview may involve one or more cases.
- A single case may include more than one drug test.
- A single drug test may be related to one or more cases, but to only a single pretrial interview.

	Event County	The county associated with an event tracked by Pretrial Services related to a defendant in pretrial custody or on pretrial release for one or more court cases related to a single interview.					
	Event Date / Drug Test Date	The date of a drug test event. In this report, these dates are reported as Calendar Year (CY, January 1 through December 31).

Database	Data Variable	Description					
	Drug Tests	A distinct count of individual drug test events. A single drug test event may be related to one or more cases, and a single case may include more than one drug test.					
	Court Cases	A distinct count of criminal cases to which the drug test events are related.					
	Interviews	The number of distinct pretrial interviews. The pretrial interview is the central data unit used in PRIM, capturing any data related to a discrete period of pretrial custody for a single defendant, which may apply to one or more cases. A single defendant may have multiple pretrial interviews during any given period of time.					
	Defendants	A count of distinct individuals related to at least one of the reported drug tests. Instances in which the same defendant is involved in more than one pretrial interview are identified when a Pretrial Officer connects the identification of the defendant in a pretrial interview to the identification entered for a previous interview involving the same defendant.


