Statistics Request Overall Description

On May 12, 2025, a request was made to Research and Statistics for the number of human trafficking charges disposed calendar years (CY) 2007 through current date statewide.

CourtNet, which provides a summary of cases statewide, was queried for charges of the human trafficking offenses included in the attached list. The report includes the specified charges disposed between 1/1/2007 and 5/30/2025 statewide.

Note: On 7/1/2020 new UOR codes were created to track different variations of human trafficking offenses, see attached list of UOR codes 25_RS3067.

Statistical Table 25_RS3062

This report includes cross-tabulations presenting the number of human trafficking charges disposed during the requested date range grouped by offense and disposition category as well as totals and a grand total for each jurisdiction. A list of the offenses queried is also included.

Page 1: Provides charges disposed in Circuit and District Court by UOR code descriptions.

Pages 2-5: Provides charges disposed in Circuit Court by charge disposition categories.

Pages 6-9: Provides charges disposed during requested timeframe in District Court by UOR code descriptions and charge disposition categories.

Page 10: Provides Circuit Court summary counts per calendar year by charge disposition category.

Page 11: Provides District Court summary counts per calendar year by charge disposition category.

Page 12: Provides a visualization of the summary counts per jurisdiction.

Statistical Analysis Considerations:

- The data provided is a snapshot in time as of the date the data was queried.
- An incomplete year is indicated by a dagger (†). Calendar Year 2025 includes counts through May 30, 2025.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.

These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. A query for data based on specified charges will include each UOR code specified and possible supplemental codes. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

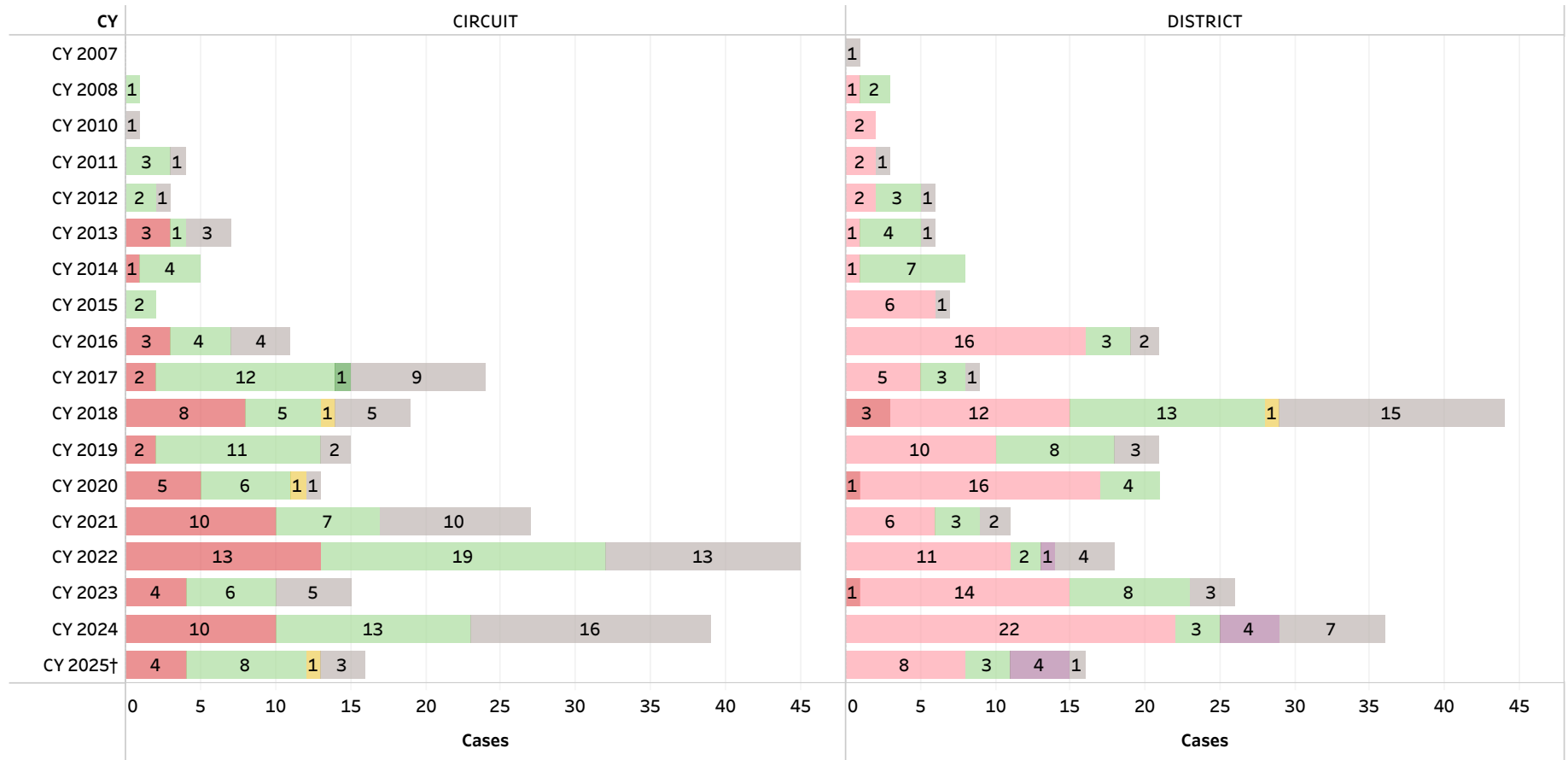
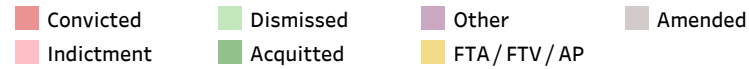
