KRS 620.030 CHARGES DISPOSED FISCAL YEARS 2021-2025 STATEWIDE

Statistics Request Overall Description

On August 1, 2025 Research and Statistics received a request for an aggregate report of KRS 620.030 charges disposed Fiscal Years (FY) 2021-2025.

The CourtNet database, which provides a summary of cases statewide, was queried for KRS 620.030 charges disposed between July 1, 2020 through June 30, 2025 statewide by county.

Statistical Reports 21_RSX4000 and 21_RSX4002

There are three reports provided with KRS 620.030 charges disposed statewide FY 21-25:

1. Failure to report dependency, neglect, and abuse;
2. Failure to report human trafficking; and
3. Failure to report female genital mutilation.

Each of the three reports contains a charge list (21_RSX4000) and is followed by a report of charges disposed statewide within the timeframe (21_RSX4002). Each charge disposition report is presented by Jurisdiction and lists the FY, county, and UOR Description. Counts are provided for charges and cases cross-tabulated by the disposition type category.

Statistical Analysis Considerations:

- These statistics represent a snapshot in time as of the date the data was queried 9/4/25.
- A case may consist of two or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals. Charges consist of all original and amended charges within a case.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at [Analytics - Kentucky Court of Justice](#). The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
