Statistics Request Overall Description

On July 13, 2021, the Warren County Attorney's Office requested from Research and Statistics a report of non-felony Driving Under the Influence (DUI) charges within cases filed from January 1, 2022, to March 31, 2022, in Warren County.

The CourtNet database, which provides a summary of cases statewide, was queried for non-felony DUI charges within cases filed from January 1, 2022, to March 31, 2022, in Warren County.

Statistical Reports 21_RSX3000 and 21_RSX3001

Statistical Report 21_RSX3000 provides a list of the Uniform Offense Reporting (UOR) Codes that were queried for Statistical Report 21_RSX3001. Statistical Report 19_RSX8001 provides a count of non-felony DUI charges within cases filed from January 1, 2022, to March 31, 2022, in Warren County broken down by jurisdiction and UOR Code/UOR Description.

- > The statistics presented are based on data collected from the CourtNet database.
- The statistics presented are a snapshot in time as of the date of the query.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case.
- Charges include ASCF Codes: 1 Attempt, 2 Solicitation, 3 Conspiracy, 4 Facilitation, 5 Complicity, 6 Enhancement.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this

period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
