Statistics Request Overall Description

On December 5, 2022, the Office of the Jefferson County Attorney requested from Research and Statistics a report of the number of non-support charges within cases filed and non-support charges convicted from January 1, 2021 to November 30, 2022.

CourtNet, which provides a summary of cases statewide, was queried for non-support charges (listed below) within cases filed and non-support charges convicted in Jefferson County from January 1, 2021 through November 30, 2022.

The UOR Codes listed below were queried for the Non-Support offense report.
(This listing includes the base code only, the additional ASCF's are included in the query)

Statistical Table (22_RS3221)

Report 22_RS3221 provides the count of charges and distinct count of cases for Jefferson County from January 1, 2021 through November 30, 2022 for each UOR code and each jurisdiction (Circuit or District Court).

The first cross table presents the number of non-support charges within cases filed during the requested date range grouped by UOR code and description cross tabulated by the year the case was filed.

The second cross table presents the number of non-support charges convicted during the requested date range by UOR code and description cross tabulated by the year the charge was convicted.

Statistical Analysis Considerations:

- The data provided is a snapshot in time as of the run date.
- An incomplete year is indicated by a dagger (†), it includes up to the most recent complete month.

Statistical Table (22_RS3221)

- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case.
- Charges include ASCF Codes: 1 - Attempt, 2 - Solicitation, 3 - Conspiracy, 4 - Facilitation, 5 - Complicity, 6 - Enhancement.

CourtNet	Jurisdiction	The jurisdiction in which each case was filed or convicted. This report includes Circuit and District Court jurisdictions.
	Calendar Year	The calendar year is from January 1 to December 31. Data was extracted for this report are 1/1/2021 – 11/30/2022.
	Case Filing Date	The date in which each charge was filed and is displayed by the year of the case filing.
	Charge Disposition Date	The date in which each charge was disposed and is displayed by the year of the charge disposition date.
	Convicted Charges	Convicted charges have been disposed as 'Guilty', 'Guilty Multiple', 'Guilty – Sealed Sentence', or 'Prepaid' and are displayed by the year the charge was convicted.
	County	The county in which the case was filed. This report was limited to Jefferson County.
	Cases	A distinct count of cases including any of the requested charges.
	Charges	A count of total charges within cases filed or convicted.
	KRS	The Kentucky Revised Statute with which each offense is associated.
	UOR Code	A code which identifies the specific offense charge brought against the defendant.
	UOR Description	The description of the specific offense the defendant is formally accused of committing.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at <https://kycourts.gov/AOC/Information-and-Technology/Analytics/Pages/default.aspx> The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
