Statistics Request Overall Description

On August 16, 2022, the Department of Specialty Courts and AOC Research and Statistics received a request for a report summarizing various Specialty Courts statistics including the number of participants with current active standing in each county from each Program Type, the total number of incoming Specialty Courts referrals from Calendar Years (CY) 2017 through 2021, and the Specialty Courts exit rate for each Exit Status (Successful Completion, Administrative Discharge, and Termination) for participants exiting Specialty Courts programs from CY 2017 through 2021.

The Adult Drug Court Management Information System (MIS) database was queried for data related to participants in Adult Drug Court, Mental Health Court, or Veterans Treatment Court. Participants from these programs were identified as follows:

- 1. **Active Standing:** Participants with an Entrance Date, no Exit Statuses, and a most recent Status indicating active participation (see definition below) as of 8/16/2022.
- 2. **Referred:** Participants with a Referral Date from 1/1/2017 through 12/31/2021.
- 3. **Exiting:** Participants with a most recent status indicating exit from Specialty Courts (see definition below) from 1/1/2017 through 12/31/2021.

Statistical Report (22 DC8002)

The statistical report consists of three pages. The first page presents information about participants with active standing, the second page presents information about incoming referrals, and the third page presents information about participants exiting Specialty Courts.

Specialty Courts Participants with Active Standing as of 8/16/2022

The first page consists of two cross-tabulations. The larger table at the top presents the number of participants with active standing as of 8/16/2022 in each county and is grouped by Program Type. The table is split into three columns. The second table at the bottom of the page presents the number of distinct counties including at least one participant with active standing as of 8/16/2022 for each Program Type and including a total of all three Program Types.

cross-tabulation presents this total as well as the number of participants referred to each Program Type separately.

Participants Exiting CY 2017-2021

The third page includes a bar graph and cross-tabulation. The bar graph presents the percentage of participants with each exit status separately for each CY. The cross-tabulation includes these percentages as well as counts of participants.

Active: A participant who was referred to Specialty Courts, was determined to be eligible for participation, has accepted participation, and who has entered a program and had at least one Active Status. Exited: A participant who has left a Specialty Courts program (had an Exit Status).




