Statistics Request Overall Description

On August 16, 2021, Research & Statistics received a request for a report of the number of Personal Injury cases filed within the last 20 years. It was also requested that the report of cases filed since the 1/1/2021 implementation of the civil cover sheet include separate totals for each Case Type.

CourtNet, which provides a summary of court cases statewide, was queried for Circuit and District Civil cases (Case Number Types CI and C) filed from 1/1/2003 to 7/31/2022 including case type codes PI (*Personal Injury*), MDML (*Medical Malpractice*), AUTO (*Automobile*), BCPI (*Business Court Personal Injury*), INTENT (*Intentional Tort*), MLOTH (*Malpractice – Other*), PIOTH (*Tort – Other*), PREM (*Premises Liability*), PROD (*Product Liability*), and SLAND (*Slander/Libel/Defamation*).

All case records have been kept in the CourtNet database, making this the earliest date for which comprehensive records can be compiled. The *Personal Injury* Case Type Code has been in use since the implementation of this database until December 31, 2020. The *Medical Malpractice* code was created on July 3, 2017. Prior to this date, these types of cases were categorized as *Personal Injury*. On January 1, 2021, the *Personal Injury* code was deprecated in favor of several more specific codes based on the Tort categories prescribed by the Court Statistics Project of the National Center for State Courts:¹

- Automobile Tort
- Intentional Tort
- Malpractice Other (Other than Medical Malpractice, implemented 7/3/17)
- Premises Liability
- Product Liability
- Slander/Libel/Defamation
- Tort Other

The category Business Court Personal Injury was also created January 1, 2021 to indicate Circuit Court cases involving complex litigation between businesses.

Statistical Report 22_RS8019

The statistical report includes two pages. The first page presents the number of *Personal Injury* cases filed from 1/1/2003 through 7/31/2022. A line chart presents the number of cases filed in each court jurisdiction (Circuit and District Court) each year, and a table at the bottom of the page includes the same counts as well as totals.

The second page is limited to cases filed from 1/1/2021 through 7/31/2022 following the implementation of the civil cover sheet. This page includes a cross-tabulation presenting the number of *Personal Injury* cases filed each month with totals provided for each Case Type and the month and year of Case Filing Date. The shading of each cell corresponds to the number of cases.

- These statistics represent a snapshot in time as of the date the data was queried (8/26/2022).
- > Reports of cases filed during CY 2022 include cases filed from 1/1/2022 through 7/31/2022.



	Case Filing Date	The date the case was filed. Case Filing Date is reported using the Calendar Year (CY) and month. The Calendar Year is January 1 st through December 31 st .								
	Tort Category (Case Type)	The type indicated in KYCourts by the case type code. This generally corresponds to the selection of case category made at filing on the civil cover sheet.								
	Cases	A count of distinct court cases.
