### POSSESSION OF MARIJUANA CHARGES CONVICTED JANUARY 1, 2017 - OCTOBER 11, 2022 STATEWIDE

### **Statistics Request Overall Description**

On October 12, 2022, Research and Statistics received a request for a report of possession of marijuana charges convicted statewide during calendar years 2017 through 2022, year to date.

CourtNet, which provides a summary of cases statewide, was queried for possession of marijuana charges convicted between 1/1/2017 and 10/11/2022. Possession of marijuana charges enhanced under KRS 218A.992 were excluded. A list of the related UOR codes is provided along with the completed reports.

### Statistical Tables (21\_RSX4000 & 21\_RSX4003)

Statistical Table **21\_RSX4000** provides the relevant KRS; UOR code and description; and the relevant charge level and class that were queried.

Statistical Table **21\_RSX4003** provides counts of the specified charges convicted during the requested timeframe. Each is listed by jurisdiction; calendar year the charges were convicted; and the UOR code and description.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at <a href="Analytics - Kentucky Court of Justice">Analytics - Kentucky Court of Justice (kycourts.gov)</a>. A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does

not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
