Statistics Request Overall Description

On February 7, 2024, Research and Statistics received a request from the Bullitt County Judge Executive's office for a recidivism report for Bullitt County Specialty Courts participants having successfully completed the Specialty Court program between January 1, 2011 and December 31, 2020.

This report is separated into four (4) sections, requiring a separate query for each section. The details of the query descriptions for each section are below:

The Specialty Courts Management Information System (AOC MIS), the case management and information system used by Specialty Courts, was queried for Bullitt County Specialty Court Participants who were identified as having a status type of *Successful Completion*, *Administrative Discharge*, or *Terminated* between the dates of 1/1/2011 and 12/31/2020.

CourtNet, which provides a summary of cases statewide, was then queried for any subsequent cases filed against the previously identified Participants having a *Successful Completion* of a Specialty Court Program. The Subsequent Cases identified in this way were used as a reference for the following queries:

- Pretrial Services Information Management System (PRIM) was queried for case data, including the booking date, for the above Subsequent cases in which the booking date of a case was identified as being within 36 months of the *Successful Completion* date.
- CourtNet was queried for any of the subsequent CourtNet cases identified above, containing at least one (1) Felony or Misdemeanor level charge convicted within 36 months of the *Successful Completion* date of the Participant.
- CourtNet was queried for any of the subsequent CourtNet cases identified above containing at least one (1) Felony or Misdemeanor level charge conviction and having a *Sentencing Date* within 36 months of the *Successful Completion* date of the Participant, limited to those subsequent cases in which the sentence required the defendant to serve time in jail or prison.

Section 1: Participants Exiting a Specialty Court 2011-2020

The top-most section displays a table and a horizontally stacked bar chart of Participants who exited the Specialty Court program during the requested timeframe in Bullitt County. Both the chart and table are grouped by exit type and present a count and percent of total Participants for each exit type.

Section 2: Time from Graduation to Re-arrest after Successful Completion

This section presents a cross-tabulation of participants having a subsequent case with a booking date within 36 months of the Participant's Successful Completion of the Specialty Court Program. The table is grouped by time to arrest and includes counts of participants, a running total of participants, and the percentage of total.

Section 3: Time from Graduation to Conviction of Felony or Misdemeanor Offenses

This section presents a cross-tabulation of participants having a subsequent case having at least one (1) Felony or Misdemeanor level charge convicted within 36 months of successfully completion of the Specialty Court Program. The table is grouped by time to conviction and includes counts of participants, a running total of participants, and the percentage of total.

Section 4: Time from Graduation to Incarceration for Felony or Misdemeanor Offenses

This section presents a cross-tabulation of participants having a subsequent case containing at least one (1) Felony or Misdemeanor level charge convicted having a sentencing date within 36 months of successfully completion of the Specialty Court Program, limited to those subsequent cases in which the sentence required the defendant to serve time in jail or prison. The table is grouped by Time to Incarceration and includes counts of participants, a running total of participants, and the percentage of total.

Statistical Analysis Considerations:

- The data file is a snapshot in time including data as it existed on the day it was queried.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

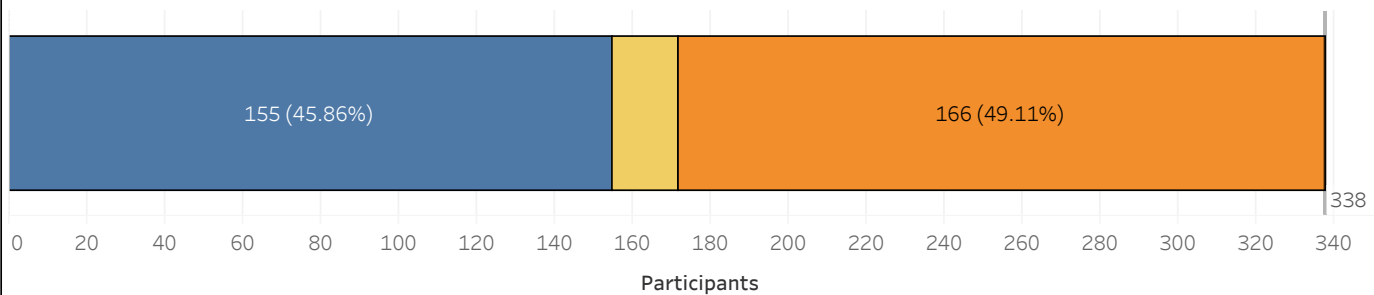
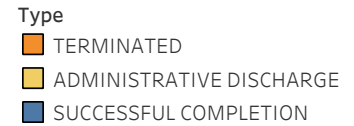
