Statistics Request Overall Description

On July 24, 2024, Research and Statistics received a request for a report of charges with one of 29 specified offenses disposed in the counties of Breathitt, Knott, Lee, Leslie, Letcher, Perry, and Wolfe from calendar year 2022 to present.

The CourtNet database, which provides a summary of cases statewide, was queried for charges disposed in the counties of Breathitt, Knott, Lee, Leslie, Letcher, Perry, and Wolfe from calendar year 2022 to present with a Uniform Offense Reporting (UOR) Code indicating one of the 29 requested offenses or one of 21 similar offenses from the same specified statutes. A list of all UOR codes which were queried for the report is attached below.

The set of queried offenses focus on sex-related crimes in which the victims are or may be children. This is not a comprehensive report of such crimes in the indicated counties. Some UOR Codes that leave the age of a victim ambiguous or unspecified are included in this report. Many sex-related crimes that may have children as victims are not identified by UOR Codes wherein the age of the victim is part of the definition for the offense. The offenses associated with the following queried UOR Codes are not by their definition limited to situations in which the victim was a minor, and any reported counts of these charges likely include situations in which the victim was an adult.

Statistical Report

The report includes a list of the specific offenses queried for the report followed by 18 pages of tabulated counts of these charges disposed during Calendar Year 2022 in the indicated counties.

Pages 10-14 provide a pair of cross-tabulations of specified charges disposed by Charge Disposition Year, UOR Code, and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided. The first of these tables (Pages 10-12) includes Circuit Court dispositions and the second of these tables (Pages 13-14) includes District Court dispositions.

Pages 15-17: provide a pair of cross-tabulation of specified charges disposed by UOR Code, and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided. The first of these tables (Pages 15-16) includes Circuit Court dispositions and the second of these tables (Page 17) includes District Court dispositions.

Page 18 provides a cross-tabulation of specified charges disposed by Jurisdiction and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided.

Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 8/14/2024.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case counted separately.
- Many but not all charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.
- Some UOR codes queried for this report leave the age of the victim ambiguous or unspecified.

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or “ASCF” codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A “0” as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the “0” will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of “*obs” within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
