Statistics Request Overall Description

On May 10, 2024, Research and Statistics received a request from a member of the news media for an aggregate report of rape, sodomy, or sex abuse charges filed in Jefferson County Circuit Court for calendar years 2017, 2018, 2019, 2022, and 2023.

CourtNet, which provides a summary of cases statewide, was queried for charges with an AOC Offense Category of rape, sodomy, or sex abuse within cases filed in circuit court statewide from 1/1/2017 through 12/31/2023. Thus, the years 2020 and 2021 were included as well. Statewide aggregates are provided in addition to data from Jefferson County as a point of comparison.

Statistical Tables (21_RSX6000, 21_RSX6001)

- **21_RSX6000:** Provides a list of base charges which were queried for the report by AOC Offense Category, KRS, UOR Code, UOR Description, and Charge Level and Class. Inchoate variants of these base charges are present in the aggregates.
- **21_RSX6001:** Provides 21 pages of aggregations that display counts of charges with an AOC Offense Category of rape, sodomy, or sex abuse within cases filed in Circuit Court from 1/1/2017 12/31/2023
- **Pages 1-5:** Provide a cross-tabulation that displays counts of the specified charges filed in Jefferson County Circuit Court grouped by UOR code and case filing year. Additionally, a count of distinct cases containing those charges is provided.
- **Page 6:** Provides a cross-tabulation that displays counts of the specified charges filed in Jefferson County Circuit Court grouped by case filing year. Additionally, a count of distinct cases containing those charges is provided.
- Pages 7-20: Provide the same information found in pages 1-5 but on the statewide level.
- Page 21: Provides the same information found on page 6 but on the statewide level.

Statistical Tables (21 RSX6000, 21 RSX6001)

- These statistics represent a snapshot in time as of the run date (5/15/2024).
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not represent counts of individual defendants as the same defendant may appear in multiple cases.
- > Charges consist of all original and amended charges within a case counted separately.
- A case may consist of charges which fall under different groups within a table. In this situation, a case is added to the case count for each group which applies to at least one charge within a case. Each subtotal displays the quantity of distinct cases and charges for that group, causing subtotals of case counts to add up to a number greater than the actual overall total.

CourtNet	Case Filing Date	The date each case was filed. Case Filing Date is reported by Calendar Year. The Calendar Year is January 1 through December 31. This report is limited to charges with a case filing date between 1/1/2017 and 12/31/2023.

	Jurisdiction	The jurisdiction in which each case was filed.
	AOC Offense Category	A classification of criminal offenses created by Research & Statistics to identify related offenses for statistical purposes. This report is limited to charges with an AOC Offense Category of Rape, Sodomy, or Sex Abuse.
	UOR Code	A numeric label for a specific statute-based charge used in a Uniform Offense Report. The first six digits of a UOR Code are unique to each statutory offense. The seventh digit ranges from 0 through 6. A final "0" indicates that only the underlying statutory offense is charged. "1" indicates that an attempt has been charged. "2" shows that a solicitation has been charged. "3" shows a conspiracy charge. "4" shows a facilitation charge. "5" shows a complicity charge. "6" shows that the underlying charge has been enhanced.

	Offense Description	A brief verbal summary of the statutory offense which is the basis for the type of criminal offense with which the defendant has been charged. In a related example, UOR Code "0008051" represents the related ASCF code or Inchoate offense of "ATTEMPTED BOMB THREATS".

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
