Statistics Request Overall Description

On October 14, 2025, Research and Statistics received a request for a report of Driving Under the Influence, Possession of Marijuana, Theft by Unlawful Taking, and Failure to Maintain Insurance charges within cases filed and a report of the specified misdemeanor charges disposed federal fiscal year (FFY) 2025 in Fayette County

The CourtNet database, which provides a summary of cases statewide, was queried for the specified charges within cases filed and was then queried for the specified charges disposed from October 1, 2024 through September 30, 2025 in Fayette County.

Statistical Reports 21_RSX4000, 21_RSX4001, and 21_RSX4002

Statistical Report 21_RSX4000 provides a list of the Uniform Offense Reporting (UOR) Codes that were queried for Statistical Report 21_RSX4001 and 21_RSX4002.

Statistical Report 21_RSX4001 provides a count of the specified charges within cases filed in Fayette County FFY 2025.

Statistical Report 21_RSX4002 provides a count of the specified charges disposed in Fayette County FFY 2025.

Statistical Analysis Considerations:

- The statistics presented are a snapshot in time as of the date the data was queried: 10/29/2025.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals.
- Charges consist of all original and amended charges within a case.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts.
