### Statistics Request Overall Description

On October 3, 2024, Research and Statistics received a request from the Kentucky Association of Sexual Assault Programs for an aggregate report with counts of charges pending in the counties of Bourbon, Scott, and Woodford counties that are associated with Kentucky Revised Statutes (KRS) 510, 530, or 531.

The CourtNet database, which provides a summary of cases statewide, was queried for pending charges associated with the requested statutes for the counties of Bourbon, Scott, and Woodford.

### Statistical Reports

Statistical Report **24\_RS6070** consists of two pages of data aggregations which display counts of the specified pending charges as of the run date.

**Page 1** consists of a cross-tabulation that displays a count of specified charges pending in Circuit Court in the requested counties. These counts are broken down by AOC Offense Group, AOC Offense Category, KRS, and UOR Code and Description. Additionally, counts of distinct cases containing these charges are provided.

**Page 2** consists of two cross-tabulations that display a count of specified charges pending in District Court in the requested counties. In both tables, these counts are broken down by AOC Offense Group, AOC Offense Category, KRS, and UOR Code and Description. The top table includes all pending charges except those with a *Grand Jury* temporary disposition. The bottom table is limited to charges with a *Grand Jury* temporary disposition. Additionally, counts of distinct cases containing these charges are provided.

Statistical Report **21\_RSX6000** Provides a list of base charges queried for the report sorted by AOC Offense Category, UOR Code, UOR Description, and Charge Level and Class. Non-base charges are not displayed on these pages but are included in the counts provided in 24\_RS6070.

### Statistical Reports

#### Statistical Analysis Considerations:

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at [Analytics - Kentucky Court of Justice \(kycourts.gov\)](http://Analytics-KentuckyCourtofJustice.kycourts.gov). A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
