**Statistics Request Overall Description**

On April 11, 2024, Research and Statistics received a request from the Pacific Institute for Research and Evaluation on behalf of the Purchase Region Health Department for an aggregate report of alcohol intoxication or possession, DUI, drug, and prescription drug related charges disposed for calendar year (CY) 2016 through calendar year 2023 in the counties of Ballard, Calloway, Carlisle, Fulton, Graves, Hickman, Lyon, Marshall, and McCracken. It was also requested that information on the age, race, and gender of the defendants for those charges be integrated into the report, as well as whether the defendant had been arrested in relation to the charge.

The CourtNet database, which provides a summary of cases statewide, was queried for charges disposed in the specified counties from 1/1/2016 to 12/31/2023. The query was further limited to charges with AOC Offense Group of DUI or an AOC Offense Category of Alcohol Intoxication, Alcohol Possession, Drug Possession, Drug Manufacturing, Drug Trafficking, Drug Paraphernalia, Drug Other, Prescription Drug Possession, Prescription Drug Forgery, Prescription Drug Trafficking, or Prescription Drug Theft. CourtNet was also queried for the age, race, ethnicity, and gender of defendants associated with those charges.

PRIM, the Pretrial Release Information Management system, was queried for the cases which contained at least one of the charges found in the CourtNet query. Charges within cases that could be found in the PRIM database were marked as having an arrest. Otherwise, cases were marked as having a citation.

**Statistical Tables (24\_RS6021, 21\_RSX6000)**

**Pages 1-8:** Provide a cross-tabulation that displays counts of specified charges disposed, grouped by jurisdiction, offense type, age range of the defendant, and arrest status for each calendar year from 2016-2023. A count of distinct cases that contain those charges is also provided.

**Pages 9-16:** Provide a cross-tabulation that displays counts of specified charges disposed, grouped by jurisdiction, offense type, race of the defendant, and arrest status for each calendar year from 2016-2023. A count of distinct cases that contain those charges is also provided.

**Pages 17-24:** Provide a cross-tabulation that displays counts of specified charges disposed, grouped by jurisdiction, offense type, gender of the defendant, and arrest status for each calendar year from 2016-2023. A count of distinct cases that contain those charges is also provided.

**Page 25:** Provides a total of the same information found on pages 1-8 for CY 2016-2023 combined.

**Page 26:** Provides a total of the same information found on pages 9-16 for CY 2016-2023 combined.

**Page 27:** Provides a total of the same information found on pages 17-24 for CY 2016-2023 combined.

**Statistical Table 21\_RSX6000:** Provides a list of base charges queried for the report sorted by AOC Offense Category, UOR Code, UOR Description, and charge level and class. Note that this does not include enhanced charges where the base charge would be a misdemeanor. These enhanced charges are, however, counted in the data aggregation.

Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 4/26/2024.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals as the same defendant may appear in multiple cases.
- Charges consist of all original and amended charges within a case counted separately.
- Many but not all charges heard in Circuit Court were previously heard in District Court and indicted by grand jury. As such, the sum of charges in District and Circuit Court will count some indicted charges twice and totals from the two jurisdictions are presented separately.
- A case may have charges with differing offense types, causing the case to appear in the column for each offense type within the case. A case may also have charges with differing AOC offense categories or level and class, which results in that case appearing in multiple rows. Each subtotal displays the quantity of distinct cases and charges for its grouping. Due to the case counting method described, subtotals of case counts will add up to a number greater than the actual overall total.

When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized.
