# TRUANCY COMPLAINTS CLOSED CY 2007 - CY 2021 "CHILD FAILURE TO APPEAR FOR PRELIMINARY INQUIRY INTERVIEW"

## **Statistics Request Overall Description**

On March 24, 2022, Research and Statistics received a request for a report of "habitual truancy" complaints closed Calendar Years (CY) 2007 to 2021 with close reason Child FTA for Preliminary Inquiry (P.I.) Interview.

Complaints were compiled from AOC CDWCMS, the case management and information system used by AOC Court Designated Workers (CDW), and this data was filtered for all habitual truancy status complaints closed between 1/1/2007 to 12/31/2021, by close reason. The complaints with close reason of Child FTA for P.I. Interview, Successful Diversion, Dismissed, or a Formal Court Referral were retained for this report with others being excluded.

## Statistical Report 22\_CDW3001

The report provides statewide complaints closed 1/1/2007 – 12/31/2021 having a status offense of Habitual Truancy, consisting of two (2) pages as described below:

## Page 1: Statewide by Complaint Close Reason

Provides a horizontal line graph of the complaints closed during the timeframe having a status offense group of "Habitual Truancy", along with the percent of those complaints that met the criteria for having close reason of Child FTA for Preliminary Inquiry (P.I.) Interview. The thickness of the horizontal line corresponds to the number of complaints closed for that calendar year.

## Page 2: Statewide by Complaint Close Reason

This page also contains a cross table of the complaints closed during the timeframe having a status offense of Habitual Truancy.

## **Statistical Analysis Considerations:**

- > The statistical information presented is a snapshot in time as of March 24, 2022.
- Counts of complaints do not equal counts of youth, since a youth may have multiple complaints.

#### **RESEARCH AND STATISTICS UOR CODE DISCLAIMER**

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statistical reports. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

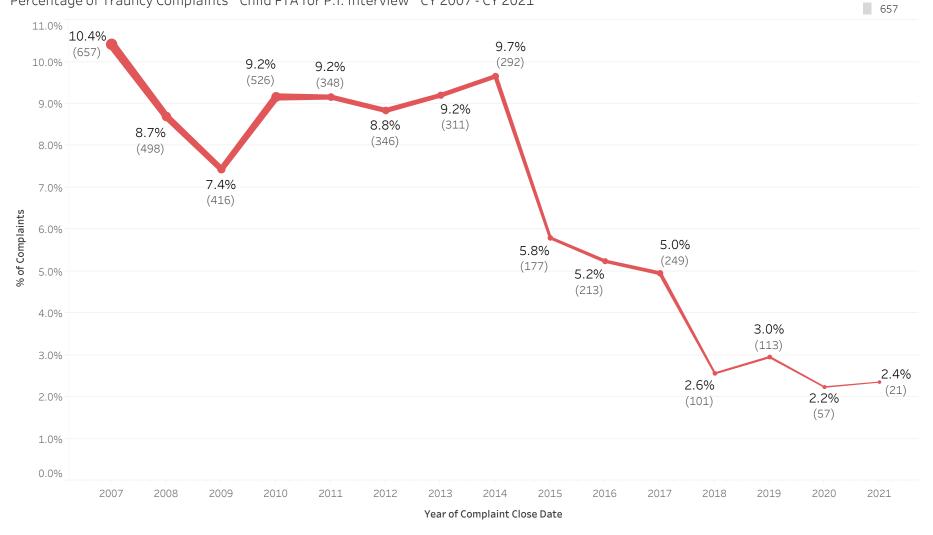


## Habitual Truancy Complaints Closed January 1, 2007– December 31, 2021 STATEWIDE
