Statistics Request Overall Description

On March 28, Research & Statistics received a report of truancy complaints filed and successfully diverted by month and calendar year for Jefferson County Kentucky between 2010 to present.

Complaints were compiled from AOC CDWCMS, the case management and information system used by AOC Court Designated Workers (CDW), and this data was filtered to include truancy charges within complaints filed between School Year (SY) 2010-2011 through SY 2021-2022 and for truancy charges within complaints closed between SY 2010-2011 through 2021-2022.

Su	uccessful Diversion	Indicates that the youth signed a diversion agreement and completed the terms of the diversion, resulting in no further action with the complaint.




