### Statistics Request Overall Description

On May 26<sup>th</sup>, 2026, Research and Statistics received a request for an aggregate report of charges related to KRS 511.110 (unlawful camping) filed from July 1, 2025, through the current date. It was requested that these counts be grouped by county and filing month.

The CourtNet database, which provides a summary of cases statewide, was queried for charges pertaining to KRS 511.110 within cases filed between 7/1/2025 and 6/1/2026. Charges with amended dispositions were excluded from this report (*Amended, Amended Down, Amended Down by Grand Jury, Amended Up, Amended Up by Grand Jury*).

### Statistical Tables (26\_RS6007)

**Page 1** provides a list of the base offenses included in the query for this report.

**Page 2** provides a cross-tabulation that displays counts of unlawful camping charges within cases filed statewide 7/1/2025 – 6/1/2026 grouped by Charge Year and Month, Jurisdiction, and UOR Description.

## Statistical Tables (26\_RS6007)

### Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 6/2/2026.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals as a defendant may appear in multiple cases.
- Reported charges consist of all non-amended charges within a case counted separately. Charges disposed with an amendment are excluded from the report while charges receiving a final disposition following an amendment are included.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at [courts.ky.gov/aoc/statisticalreports](http://courts.ky.gov/aoc/statisticalreports). A query for data based on specified charges will include each UOR code specified and possible supplemental codes. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.

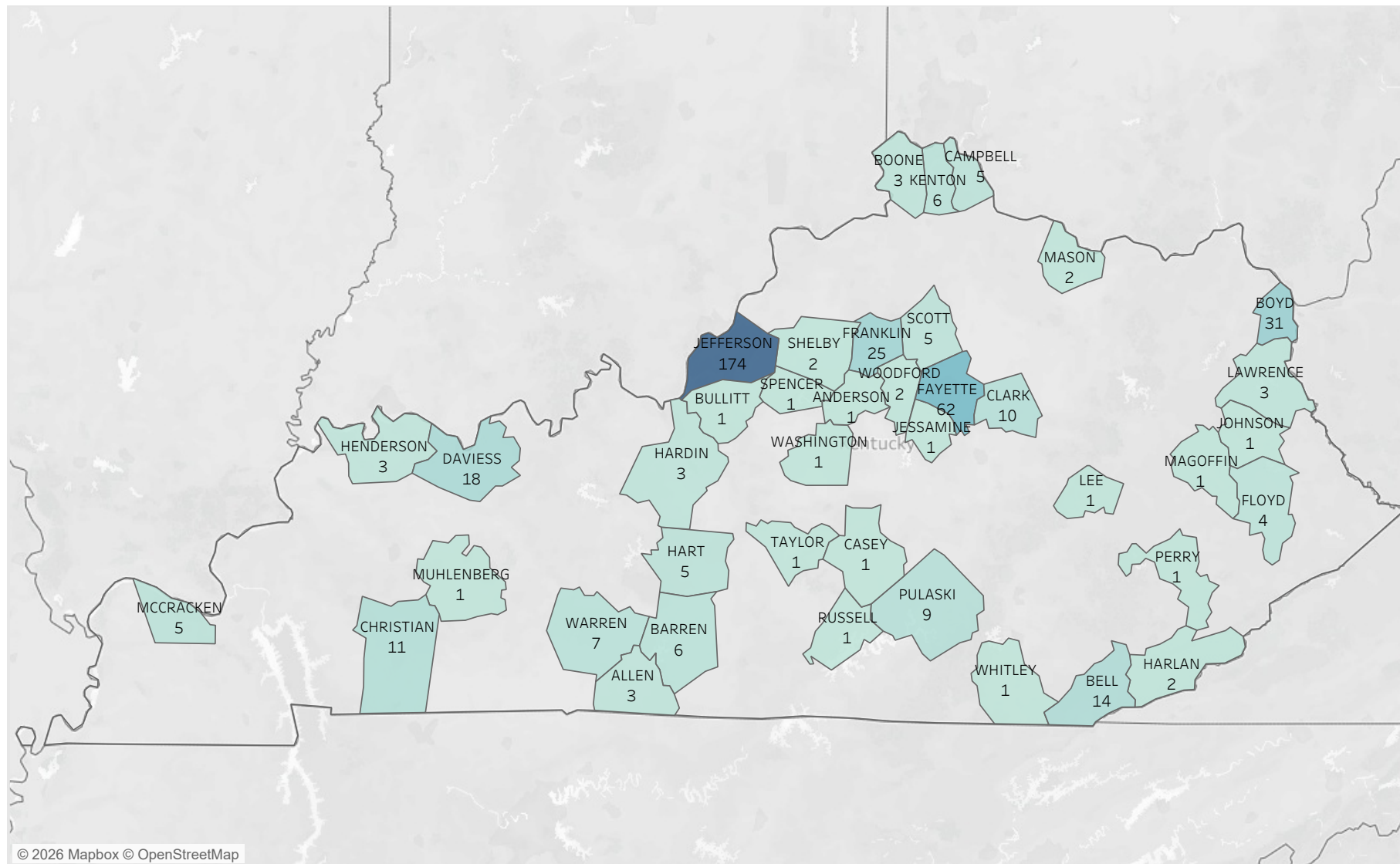

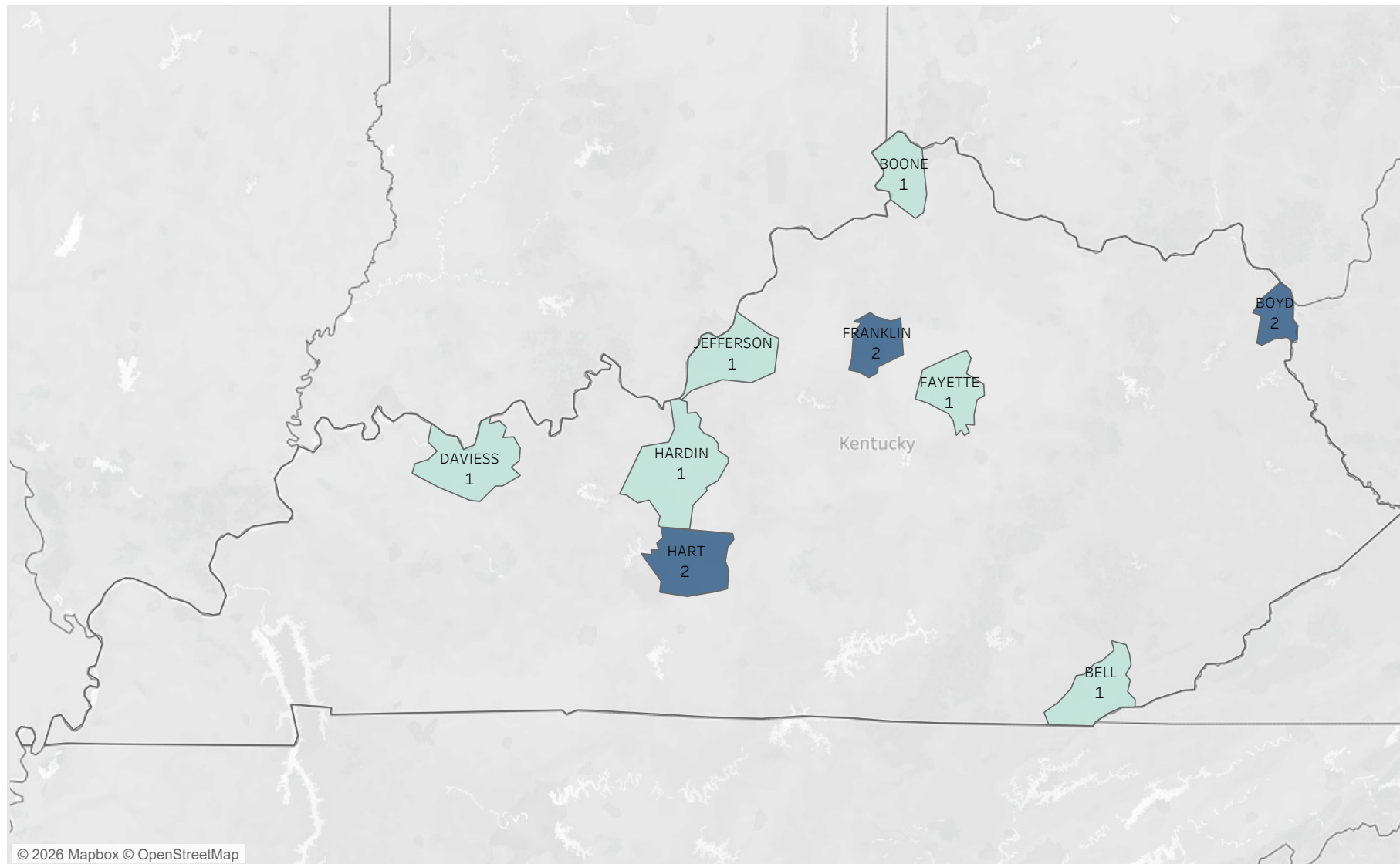
