Statistics Request Overall Description

On July 15, 2026, Research and Statistics received a request for an aggregate report of charges related to KRS 511.110 (unlawful camping) filed from July 15, 2024, through July 14, 2026. It was requested that these counts be grouped by county, filing month, and which half of the date range the case was filed in.

The CourtNet database, which provides a summary of cases statewide, was queried for charges pertaining to KRS 511.110 within cases filed between 7/15/2024 and 7/14/2026. Charges with amended dispositions were excluded from this report (*Amended, Amended Down, Amended Down by Grand Jury, Amended Up, Amended Up by Grand Jury*).

Statistical Tables (26_RS6008)

Statistical Table 26_RS6008:

Page 1 provides a list of the base offenses included in the query for this report.

Page 2 provides a cross-tabulation that displays counts of unlawful camping charges within cases filed statewide 7/15/2024 – 7/14/2026 grouped by Date Group, Charge Year and Month, Jurisdiction, and UOR Description.

Pages 3 and 4 provide a cross-tabulation that displays counts of unlawful camping charges within cases filed statewide 7/15/2024 – 7/14/2026 grouped by Date Group, Charge County, Jurisdiction, and UOR Description. Statistical Tables (26_RS6008)

Pages 7 and 8 provide maps that display counts of unlawful camping charges within cases filed in Circuit Court statewide by Charge County. Page 7 contains data for the first Date Group and Page 8 contains data for the second Date Group.

Pages 9 - 21 provide the same information seen on page 2 but further grouped by Date Group, Case Filing Year, and Case Filing Month.

Statistical Analysis Considerations:

- Statistics represent a snapshot in time, as of the date the data was queried: 8/7/2026.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Counts of cases do not necessarily represent counts of unique individuals as a defendant may appear in multiple cases.
- Reported charges consist of all non-amended charges within a case counted separately. Charges disposed with an amendment are excluded from the report while charges receiving a final disposition following an amendment are included.
- KRS 511.110 did not go into effect until July 15th, 2024. As such, charges pertaining to this statute could not be filed before then. There was a brief period where the UOR codes associated with the statute were not implemented, often causing defendants to be charged with a generic code. Those charges may have been replaced with or amended to one of the UOR codes associated with KRS 511.110 once those became available. If a charge was not changed to one of the codes associated with the statute, it is not counted in the report.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at courts.ky.gov/aoc/statisticalreports. A query for data based on specified charges will include each UOR code specified and possible supplemental codes. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
