Statistics Request Overall Description

On August 12, 2025, Research and Statistics received a request for an aggregate report of convictions and sentences for charges related to Kentucky Revised Statute 507.060 (vehicular manslaughter while under the influence) statewide from calendar year (CY) 3/1/2023 through 5/31/2025.

CourtNet, which provides a summary of cases statewide, was queried for charges associated with Kentucky Revised Statute 507.060 that were disposed from 3/1/2023 through 5/31/2025. Information on dispositions and sentences for these charges was also queried. A list of charges included in the query is provided in this report.

Sentence information is provided for convicted charges. The sentence information only represents individual charge sentence information and does not provide the overall punishment for the case/individual. The sentence lengths found in the report are based on the length of jail or prison sentence for a charge and do not account for additional factors such as probation, sentence suspension, conditionally discharge, or home incarceration.

Sentencing Information

CourtNet entries for the sentence of each charge may consist of the sentence imposed, along with any amount probated, suspended, and/or conditionally discharged, and/or sentenced to home incarceration.

Convictions of sentences with incarceration may be fully or partially suspended. When the total amount of sentence modifications is equal to the sentence imposed, the sentence may be considered fully suspended.

The amount of incarceration time sentenced is indicated as JORP (Jail or Prison). There are additional check boxes available to specifically indicate Jail and Prison, but these are not required, may not be used consistently, and no logical constraints restrict the use of these check boxes to given amounts of incarceration time sentenced. Some prison incarceration sentences of greater than a year may be served in county jails.

Statistics Request Overall Description

Factors which affect the overall remaining sentence:

- When multiple sentences of imprisonment are imposed on a defendant for more than one (1) crime, the multiple sentence time intervals can be ordered to run concurrently or consecutively as determined by the court at the time of sentence. The concurrent/consecutive indicator does not distinguish the charge(s) or case(s) the sentence was ordered to be concurrent / consecutive with.
 - a. Concurrent Sentence: A sentence for a conviction that a court orders a defendant to serve simultaneously with the defendant's sentence for a different conviction. A sentence may be fully or partially concurrent.
 - b. Consecutive Sentence: A sentence for a conviction that a court orders a defendant to serve only after he has discharged a sentence for a different conviction. A sentence may be fully or partially consecutive.
- There are additional checkboxes to capture conditional discharge time. These checkboxes are not taken into consideration within this report. These charges may be reported in the "other penalty" category.
- Probation violations involve conduct that violates any judicial order imposing supervision of a defendant. Violations of probation and supervised release may result in "Probation Revocation" which is the annulment, cancellation, or reversal of an act, with regard to probation or supervised release, the term generally refers to the judicial act of canceling the supervision in response to the offender violation the terms of supervision and impose a term of incarceration.
- Shock probation is a form of conditional early release from prison (before the full term of imprisonment expires). Upon violation of a parole condition, a parolee may be placed back in prison to complete the remainder of the sentence. (KRS 439.265)
- Set Aside/Vacated Sentence When a sentence for one or more charges is set aside or vacated, the sentence information is removed and can no longer be reported.
- Expungement of Conviction When one or more charges within a case is granted expungement, it can no longer be reported as the sentence information for these charges is removed as part of the expungement process.

Statistical Reports (21_RSX6000, 21_RSX6002, & 25_RS6020)

21_RSX6000 provides a list of charges queried for the report by KRS, UOR Code, UOR Description, and Charge Level and Class.

21_RSX6002 provides 4 pages of data aggregations containing counts of charges of vehicular homicide while under the influence that were disposed statewide between 3/1/2023 and 5/31/2025.

Pages 1-2 provide a cross-tabulation of specified charges disposed by Jurisdiction, Calendar Year, UOR Code, and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided.

Pages 3-4 provide a cross-tabulation of specified charges disposed by Jurisdiction, Calendar Year, and Charge Disposition Category. Additionally, counts of distinct cases containing those charges are provided.

Statistical Reports (21_RSX6000, 21_RSX6002, & 25_RS6020)

25_RS6020 provides 5 pages of data aggregations of specified offenses convicted statewide in Circuit Court from 3/1/2023 through 5/31/2025.

Note: None of the specified charges convicted were given Life, Death, or 25 Years No Parole Sentences.

Page 1 provides a cross-tabulation that displays counts of the specified convicted charges, grouped by KRS, UOR Code, Charge Level and Class, Charge Description, and Sentence Time Imposed in Years. Additionally, counts of distinct cases that contain these charges are provided.

Page 2 provides a cross-tabulation that displays counts of the specified convicted charges, grouped by KRS, UOR Code, Charge Level and Class, Charge Description, and highest penalty served. Additionally, counts of distinct cases that contain these charges are provided.

Page 3 provides a cross-tabulation that displays counts of the specified convicted charges, grouped by KRS, UOR Code, Charge Level and Class, Charge Description, highest penalty served, and alternative sentence and conditions. Additionally, counts of distinct cases that contain these charges are provided. Charges may be given multiple conditions. The same charge may be counted in multiple alternative sentence and condition categories.

Note: These charges had no alternative sentences or conditions.

Page 4 provides a cross-tabulation that displays counts of the specified convicted charges with a fine imposed, grouped by KRS, Highest Penalty Served, and Fine Status. Fine statuses are as follows:

- Charges with a fine amount imposed, *partially* suspended, or conditionally discharged.
- Charges with a fine amount imposed, *not* suspended, probated, or conditionally discharged.
- Charges with a fine amount imposed, *totally* suspended, probated, or conditionally discharged.

Statistical Analysis Considerations:

- These statistics represent a snapshot in time as of the date the data was queried (8/27/2025)
- The sentence information in this report represents only the sentence ordered for that *charge* and does not provide the overall punishment for the case or for the individual.
- Sentence time entered represents the sentence ordered by the court. Subsequent modification to the length of incarceration by the Department of Corrections is not reflected in this report.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges within the case.
- Counts of cases do not necessarily represent counts of unique individuals.

The Kentucky State Police (KSP) assigns the Kentucky Uniform Crime Reporting Codes (UOR Codes) to criminal offenses in the Commonwealth of Kentucky. The KSP official list of UOR Codes by KRS number and descriptor can be obtained at the KSP's website at www.kentuckystatepolice.org.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at <https://kycourts.gov/AOC/Information-and-Technology/Analytics/Pages/default.aspx>. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
