

WARREN COUNTY YOUTH LANGUAGE CDW COMPLAINTS FILED CY 2016 – 2021 WARREN COUNTY

Statistics Request Overall Description

On August 19, 2022, Research and Statistics received a request for a report of the number of complaints filed starting from Calendar Year (CY) 2016 to 2021 for Warren County broken down by Youth Language.

The AOC Court Designated Workers Case Management System (CDWCMS), the case management and information system used by Court Designated Workers, was queried for Complaints filed in CY 2016, 2017, 2018, 2019, or 2021, in Warren County, and Youth Language associated with those Complaints.

Statistical Report (22_CDW5002)

The report consists of a single cross-tabulation that includes complaints filed by CY 2016-2021, in Warren County, and the Youth Language associated with those complaints. The table includes separate counts of complaints and distinct youth grouped by the Calendar Year of complaint filing date and the Youth Language.
