**Statistics Request Overall Description**

On February 15, 2023, the Jefferson County Attorney's Office requested a report of adult cases filed statewide and in Jefferson County 7/1/2021 – 6/30/2022 involving Unlawful Possession of Weapon on School Property offenses (052204).

CourtNet, which provides a summary of cases statewide, was queried for the timeframe of July 1, 2021 to June 30, 2022 for Circuit Criminal (CR) and District Felony (F) cases filed Statewide and in Jefferson County involving Unlawful Possession of Weapon on School Property charges. See the *Supplemental List of Offenses (23\_RS3027)* for a complete listing of offenses included in this report.

**Statistical Report (23\_RS3027 & 23\_RS3028)**

**Report 23\_RS3027:** Provides a *Supplemental List of Offenses* by Kentucky Revised Statute (KRS), UOR Description, Charge Level and Class.

**Report 23\_RS3028** provides Circuit Criminal (CR) and District Felony (F) cases filed during the requested timeframe having one or more of the specified charges within the case, the table on the left provides statewide counts (including Jefferson) and the table on the right is limited to Jefferson County. The information is additionally broken down by the charge disposition type.

Statistical Analysis Considerations:

- The data presented is a snapshot in time as of February 20, 2023.
- Counts of cases should not be considered counts of individuals, as some individuals could be involved with multiple filed cases.
- A case may consist of one or multiple charges. The report's count of cases represents a distinct count of case numbers, regardless of the number of charges associated with the case.
- Charges included in this report include ASCF Codes (1-Attempt, 2-Solicitation, 3-Conspiracy, 4-Facilitation, 5-Complicity, 6-Enhancement); however, only the base charge description is displayed for grouping purposes.

The AOC assigns and maintains codes that are used within the Court of Justice Case Management System for statistical and reporting purposes. These codes are used to identify local and city ordinances, as well as codes for general administrative purposes. The AOC official list of UOR Codes with KRS number and descriptor can be obtained at the Court of Justice Website at <https://kycourts.gov/AOC/Information-and-Technology/Analytics/Pages/default.aspx>. The AOC UOR Code Listing is for informational purposes only and the information is subject to change, reprogramming, modifications of format, and availability at the direction of the Administrative Office of the Courts (AOC).

A query for data based on specified charges will include each UOR code specified and possible supplemental codes. Supplemental codes (or "ASCF" codes) to any UOR code include: 1) attempt, 2) solicitation, 3) conspiracy, 4) facilitation, 5) complicity, and 6) enhancement. In total, UOR codes contain seven digits. The first six digits are specific to that charge. The seventh digit indicates if there is a supplemental code. A "0" as the seventh digit means that is the primary UOR code and it does not have a supplemental code. If there are supplemental codes, the "0" will change to a 1, 2, 3, 4, 5, or 6 (the numbering corresponds to the list above). An enhancement does not exist on all UOR codes. When a supplemental code does not appear within a dataset, charge(s) did not occur during this period. The presence of "\*obs" within the description of a UOR code indicates an obsolete UOR code. However, the code is still present within the KYCourts/CourtNet database and may still be utilized. Not every UOR code included in the query will have charges associated with it in each calendar year examined. Some cases may contain multiple charges; therefore, charge counts may exceed case counts. The number of cases cannot be inferred as the number of individuals as multiple cases may have the same defendant.
