AMENDED ORDER

I. Introduction

This order hereby authorizes a pilot project for the implementation of the Laura and John Arnold Foundation (LJAF) Risk Assessment and Non-Financial Uniform Schedule of Bail in Ballard, Barren, Bath, Butler, Carlisle, Campbell, Jefferson, Johnson, Knox, Laurel, Lawrence, Letcher, Martin, Menifee, Metcalfe, Montgomery, Ohio, Pike & Rowan Counties ("Pilot Counties."). The district judges in the Pilot Counties have agreed to participate in this pilot project at the request of the Supreme Court of Kentucky. The pilot project will be in effect from September 1, 2013, to August 31, 2015.

II. Purpose

The purpose of this pilot project is to test the effectiveness of the LJAF Risk Assessment and Non-Financial Uniform Schedule of Bail to expedite pretrial release of low to moderate risk defendants charged with non-violent, non-sexual misdemeanors and certain Class D felony offenses and to increase efficiency by reserving resources for higher-risk defendants ordered to pretrial supervision.

III. Implementation

A. Implementation Date

The district judges in the Pilot Counties will implement the pilot project on or after September 1, 2013.

B. Use of Proposed Schedule and Exceptions

Pilot Counties will use the Uniform Local Protocol for the LJAF Risk Assessment and Non-Financial Uniform Schedule of Bail Pilot Project as attached, with the following exceptions:

1. In Butler and Ohio Counties:

- a. The following non-violent, non-sexual offenses are not eligible for release under the Schedule and require judicial review:
 - i. DUI 1st offense with a BAC of 0.15 or higher;
 - ii. DUI 1st offense with a refusal.
- b. Eligible defendants assessed as being low or low-moderate risk shall be released under the Schedule on a \$500 unsecured bond if the highest charge is a violation or misdemeanor.
- c. Eligible defendants assessed as being low risk shall be released under the Schedule on a \$1,500 unsecured bond if the highest charge is a Class D felony.
- d. Pretrial Services shall not override the risk assessment score or level for any failures to appear.
- e. Moderate risk defendants are not eligible for release under the Schedule and require judicial review.

2. In Barren and Metcalfe Counties:

- a. The following non-violent, non-sexual offenses are not eligible for release under the Schedule and require judicial review:
 - i. DUI 1st offense with a BAC of 0.15 or higher;
 - ii. DUI 1st offense with a refusal;
 - iii. DUI 1st offense where the defendant does not possess a valid, Kentucky license.
- b. Eligible defendants being assessed as low or low-moderate risk shall be released under the Schedule on a \$500 unsecured bond if the highest charge is a violation or misdemeanor.
- c. Eligible defendants being assessed as low risk shall be released under the Schedule on a \$1,500 unsecured bond if the highest charge is a Class D felony.
- d. Moderate risk defendants are not eligible for release under the Schedule and require judicial review.

3. In Johnson, Martin and Lawrence Counties:

a. The following non-violent, non-sexual offenses are not eligible for release under the Schedule and require judicial review:

- i. Any DUI offense;
- ii. Any felony, drug-related offense.
- b. Eligible defendants assessed as being low, low-moderate, moderate, or moderate-high risk shall be released under this Schedule on recognizance, an unsecured bond or a surety bond.
- c. Eligible defendants assessed as low-moderate, moderate or moderate-high risk shall be supervised by Pretrial Services per the risk/needs matrix.
- d. The Pretrial Services risk assessment shall not calculate failure to appear on any non-DUI traffic case.
- e. If a defendant's risk level is affected by a case, whether a conviction or an unresolved case, in which the charge date is greater than 10 years old, no points shall be assessed for such cases on the LJAF Risk Assessment.

4. In Ballard and Carlisle Counties:

- a. The following non-violent, non-sexual offenses are not eligible for release under the Schedule and require judicial review:
 - i. DUI 1st offense with a BAC of 0.15 or higher;
 - ii. DUI 1st offense with a refusal:
 - iii. DUI 1st offense where the defendant does not possess a valid, Kentucky license.
- b. Eligible defendants being assessed as low or low-moderate risk shall be released under the Schedule on a \$500 unsecured bond if the highest charge is a violation or misdemeanor.
- c. Moderate risk defendants are not eligible for release under the Schedule and require judicial review.
- d. Defendants whose highest charge is a class D felony or higher are not eligible for release under the Schedule and require judicial review.
- e. Pretrial Services shall not override the risk assessment score or level for any failures to appear.
- f. If a defendant's risk level is affected by a case, whether a conviction or an unresolved case, in which the charge date is

greater than 10 years old, no points shall be assessed for such cases on the LJAF Risk Assessment.

5. In Bath, Menifee, Montgomery and Rowan counties:

- a. The only defendants that are eligible for release under the Schedule are those charged with the offenses listed in Appendix D.
- b. Moderate risk defendants are not eligible for release under the Schedule and require judicial review.
- c. Eligible defendants being assessed as low risk charged with an offense listed in Appendix D other than those charges listed in 5(d) shall be released on a \$500 unsecured bond.
- d. Eligible defendants being assessed as low risk charged with theft by unlawful taking/misdemeanor shoplifting; operating on a suspended license; possession of marijuana; possession of a legend drug; or cultivating marijuana under 5 plants and being assessed as low risk shall be released on a \$750 unsecured bond.
- e. Eligible defendants whose risk level has been assessed as low-moderate shall be released, after judicial approval, on an unsecured bond as defined in subsections (c) and (d), above).
- f. Pretrial Services shall not override the risk assessment score or level with the exception of one prior failure to appear on a traffic offense more than three years from the time of arrest.

6. In Jefferson County:

- a. Defendants who are eligible for non-financial release under the Schedule are those who have been assessed as a low risk, a low-moderate risk, or a moderate risk (subject to paragraph "b" below) and are charged with the offenses listed in Appendix E.
- b. Eligible defendants assessed as a moderate risk shall be released on their own recognizance and supervised by Pretrial Services per the risk/needs matrix as to the following offenses:
 - i. DUI 1st (true first*, no accident, Ky resident, no pending DUI);
 - ii. DUI 1st w/Agg. (true first*, no accident, Ky resident, no pending DUI);
 - iii. DUI under 21 (true first*, no accident, Ky resident, no pending DUI);

- iv. Theft By Unlawful Taking u/\$500 shoplifting;
- v. Tampering w/Physical Evidence drugs;
- vi. Fraudulent use of Credit Card;
- vii. Criminal Mischief 2nd;
- viii. Receiving Stolen Property u/\$500;
 - ix. Possession of Controlled Substance 2nd;
 - x. Trafficking in Marijuana 1st Offense less than 8 oz;
- xi. Cultivate Marijuana 5 Plants or Less;
- xii. Failure of Owner to Maintain Required Insurance 2nd;
- xiii. Owner Permit Other to Operate w/o Required Insurance 2nd;
- xiv. Driving w/o License/Negligent in Accident.
- c. Defendants who have been assessed as moderate-high risk or high risk are not eligible for release under this Order and require judicial review.
- d. Pretrial Services shall not override the risk assessment level with the exception of one prior failure to appear on a traffic offense violation more than three years from the time of this arrest.
- e. Pretrial shall base its review on the actual charge indicated in the narrative of the citation rather than the UOR code.
- f. If the Defendant is arrested on a bench warrant for failing to appear in court and he/she has previously failed to appear on that case then judicial review is required.
- g. If the Pretrial Officer believes that the facts associated with the charges or any other factors require judicial review, then the Pretrial Officer shall present the Defendant's bond decision to the on-call judge who shall release the Defendant or set a bond.

7. In Knox and Laurel Counties:

- a. The following non-violent, non-sexual offenses are not eligible for release under the Schedule and require judicial review:
 - i. Any felony charge;
 - ii. DUI 1st offense with a BAC of 0.15 or higher;
 - iii. DUI 1st offense with a multi-vehicle accident;
 - iv. DUI 1st offense with children present;
 - v. DUI 1st offense and the defendant is a non-resident of Kentucky;
 - vi. DUI 1st offense with DUI charge that is currently pending in front of the court;

- vii. Any theft related charge(s) where the defendant has a prior conviction for theft within the past 5 years;
- viii. Any charge where the defendant has a pending misdemeanor or felony on his/her criminal history.

8. In Letcher County:

- a. The following non-violent, non-sexual offenses are not eligible for release under the Schedule and require judicial review:
 - i. Any DUI offense;
 - ii. Any felony offense;
 - iii. Endangering the Welfare of a Minor;
 - iv. Any offense charged as a bench warrant.
- b. Eligible defendants assessed as being low, low-moderate, moderate, or moderate-high risk shall be released under this Schedule on an unsecured bond.
- c. Eligible defendants assessed as low-moderate, moderate or moderate-high risk shall be supervised by Pretrial Services per the risk/needs matrix.
- d. No overrides found below in Part II, Section (4) apply.

B. Means of Implementation and Effect

The district judges in the Pilot Counties will implement the pilot project by means of an administrative or general order setting out their respective county's Non-Financial Uniform Schedule of Bail pursuant to and in accordance with the terms and provisions set forth in this order. While such an order constitutes an exception to this Court's longstanding requirement that matters affecting practice and procedure are more appropriately addressed by way of court rules,¹ this Court deems that an administrative or general order setting out the Non-Financial Uniform Schedule of Bail for each of the Pilot Counties is necessary under the circumstances to further the purpose of this pilot project. Thus, until such time as this pilot project expires or this Court amends or supplants the terms and provisions herein as to any county or counties, whichever occurs sooner, any administrative or general order promulgated pursuant to and in accordance with the terms and provisions herein will be of binding force and effect as if submitted to and approved by this Court.

C. Information Gathering

Pretrial Services will gather, monitor and coordinate the gathering of data necessary to monitor and evaluate the effectiveness of the LJAF Risk Assessment and Non-Financial Uniform Schedule of Bail Pilot Project. Evaluations, comments, and recommendations will be given quarterly to the Chief Justice of the Supreme Court of Kentucky.

IV. Governance

This pilot project will be governed by the Uniform Local Protocol for the LJAF Risk Assessment and Non-Financial Uniform Schedule of Bail Pilot Project and all applicable statutes and rules not inconsistent with said Schedule.

V. Termination or Expansion

The Chief Justice has the sole authority to amend, terminate or expand the scope of this pilot project. Requests for amendments, or changes, should be submitted to the Chief Justice.

UNIFORM LOCAL PROTOCOL FOR THE LJAF RISK ASSESSMENT AND NON-FINANCIAL UNIFORM SCHEDULE OF BAIL PILOT PROJECT

PART I: DEFINITIONS

As used in these sections, unless the context otherwise requires:

- A. "Interview" means an investigation of a defendant for the purposes of pretrial release or pretrial supervision.
- B. "Investigation" means a Pretrial Services investigation containing Courtnet and NCIC records, charge information, personal information and demographics, probation status, address, and application of the LJAF Risk Assessment (See Appendix A).
- C. "Non-Financial Uniform Schedule of Bail" means the authority granted by the court to a pretrial officer to apply a pre-determined release decision to detained defendants based on a uniform schedule of bail without the need for a judicial review.
- D. "LJAF Risk Assessment" means the validated risk assessment tool used in Kentucky, containing questions relating to flight risk and anticipated criminal conduct.
- E. "Risk assessment" means an objective, research based, validated assessment tool that measures a defendant's risk of flight and risk of anticipated criminal conduct while on pretrial release pending adjudication.
- F. "Risk level" means a scale from low to high of the risk a defendant poses of pretrial failure (e.g., failure to appear or presenting a danger to the community).
- G. "Risk/Needs Matrix" means the evidence-based, standardized template of the pretrial services agency which associates a defendant's risk level and needs level with a corresponding level of supervision.
- H. "Sexual Offenses" means any offense defined as sexual under Kentucky Revised Statutes and those listed by Pretrial Services as sexual for purposes of Pretrial release (See Appendix C).
- I. "Supervision" means the placement of a defendant under supervision of Pretrial Services' Monitored Conditional Release program with conditions imposed by the court or pretrial services agency.

- J. "Verification" means matching a defendant's identity with an official record.
- K. "Verified and eligible defendant" means a defendant who is charged with a bailable offense and whose identity Pretrial Services is able to confirm through investigation.
- L. "Violent Offenses" means any offense defined as violent under Kentucky Revised Statutes and those listed by Pretrial Services as violent for purposes of Pretrial release (See Appendix B).

PART II: PILOT PROGRAM FOR THE PRETRIAL RISK ASSESSEMENT AND NON-FINANCIAL UNIFORM SCHEDULE OF BAIL

Section 1. Obligations of Pretrial Services and Pretrial Officers

Except where explicitly noted, no provision set forth in this order shall absolve the Administrative Office of the Courts' pretrial services agency and pretrial officers employed by the agency from following the Kentucky Rules of Criminal Procedure, including but not limited to: RCr 4.02, RCr 4.06, RCr 4.08, and RCr 4.38; and the Kentucky Revised Statutes, including but not limited to: KRS 431.066, KRS 431.515, and KRS 431.518.

Section 2. Risk Assessment and Risk Level

- A. All verified and eligible defendants will have their risk level assessed by use of the LJAF Risk Assessment.
- B. The risk assessment instrument, once applied to a defendant, will result in the defendant's risk level being assessed as either:
 - i. Low
 - ii. Low-moderate
 - iii. Moderate
 - iv. Moderate-High
 - v. High
- C. The risk assessment instrument will be applied to the defendant prior to or at the approximate time of the pretrial interview. Nothing in this order shall prohibit the instrument from being re-applied to the defendant at any time after the initial application.

Section 3. Eligibility and Release Options

- A. Defendants charged with non-violent/non-sexual misdemeanor(s)/violation(s) whose risk level has been assessed as either low or low-moderate will be eligible under the Schedule and shall be released on recognizance with conditions as ordered by the court.
- B. Defendants charged with non-violent/non-sexual misdemeanor(s)/violation(s) whose risk level has been assessed as moderate will be eligible under the Schedule and shall be released on recognizance with supervision per the Pretrial Services risk/needs matrix.
- C. Defendants charged with one or more non-violent/non-sexual Class D felonies whose risk level has been assessed as low will be eligible under the Schedule and shall be released on recognizance or unsecured bond with conditions as ordered by the court.
- D. Defendants charged with one or more non-violent/non-sexual Class D felonies whose risk level has been assessed as low-moderate or moderate will be eligible under the Schedule and shall be released on recognizance or unsecured bond with supervision per the Pretrial Services risk/needs matrix.
- E. Defendants charged with contempt of court and/or with violation(s) of misdemeanor or felony probation or conditional discharge are not eligible under the Schedule.
- F. Defendants charged with a DUI 1st offense with injuries or accident or any aggravated circumstances (other than refusals and DUI 2nd or greater) are not eligible under the Schedule. All statutory times shall be followed for all DUI offenses.
- G. Defendants charged with driving on a DUI suspended license are not eligible under the Schedule.
- H. Defendants who have previously failed to appear on the charge are not eligible under the Schedule.
- I. Defendants charged with Fugitive from Justice are not eligible under the Schedule.
- J. Defendants charged with trafficking in a controlled substance (Class D felony or higher) that have a pending trafficking in a controlled substance charge of

- any type or prior conviction for a trafficking in a controlled substance charge of any type are not eligible under the Schedule.
- K. Defendants who decline the pretrial services interview are not eligible under the Schedule.
- L. All defendants not eligible for release under the Schedule shall only be released upon judicial review with supervision and conditions of release ordered by the court.

Section 4. Overrides

- A. If a defendant's risk level is affected by a failure to appear (FTA) on a traffic offense no points shall be assessed for such events on the LJAF Risk Assessment.
- B. If a defendant's risk level is affected by a case, whether a conviction or an unresolved case, in which the charge date is greater than 10 years old (exclude class A, B and C felonies), no points shall be assessed for such cases on the LJAF Risk Assessment.
- C. If at any time the pretrial officer feels the facts associated with the charges or any other factors require judicial review then the pretrial officer may present the defendant to the on-call judge to set bond.
- D. The pretrial officer shall base his or her review on the actual charge indicated in the narrative/criminal record rather than the UOR code assigned by law enforcement.
