#### **ORDER**

# IN RE: EXEMPTION FROM SPECIAL EXAMINATION UNDER SCR 1.060(4)

On December 2, 2017, the Administrative Office of the Courts administered a standard examination to individuals seeking a certification of qualification for candidacy to the office of circuit court clerk under Supreme Court Rule (SCR) 1.060(2). The names of individuals receiving a passing grade of 70% or more were certified to the Secretary of State by letter dated December 7, 2017, a copy of which is attached to this Order. Those individuals are eligible to run for the office of circuit court clerk in the 2018 general election.

Under SCR 1.060(4), the Administrative Office of the Courts is required to prepare and administer a special examination to such persons designated by the chief circuit judge when there is a vacancy in the office of circuit clerk.

Individuals must receive a passing score on a special examination to be eligible for appointment or election to fill an unexpired term.

It is anticipated there will be vacancies in the office of circuit court clerk prior to the start of the new term of office on January 1, 2019, and that individuals who received a passing score on the standard examination may seek to be appointed to fill these vacancies. Accordingly, the Chief Justice has determined that an exception to the requirement for a special examination under SCR 1.060(4) is justified. To avoid the unnecessary administration of a

special examination, individuals who received a passing grade on the December 2, 2017, standard examination and whose eligibility as a candidate has been certified to the Secretary of State are not required to take a special examination to be eligible for an appointment to the office of circuit court clerk from the date of this Order until January 1, 2019.

Accordingly, it is ORDERED that those individuals whose eligibility was certified by the Administrative Office of the Courts to the Secretary of State by letter dated December 7, 2017, are exempt from the special examination required under SCR 1.060(4) until January 1, 2019. Nothing in this order will preclude a chief circuit judge from designating a person who did not take the December 2, 2017, standard examination to take a special examination should a vacancy occur.

This Order is effective December 7, 2017, *nunc pro tunc*, and until further Order of this Court. This Order will expire on January 1, 2019.
