#### AMENDED ORDER

# IN RE: Authorization for the Non-Financial Uniform Schedule of Bail Pre-Arraignment Release Protocol

This order hereby amends Supreme Court Order 2024-42, the Non-Financial Uniform Schedule of Bail Pre-Arraignment Release Protocol ("Pre-Arraignment Release Protocol").

No local rules, practices, procedures, orders, or other policies of any district or circuit may conflict with or controvert this order; further, to the extent that any such local rules, practices, procedures, orders, or other policies are inconsistent or otherwise conflict with this order, this order shall prevail.

# NON-FINANCIAL UNIFORM SCHEDULE OF BAIL PRE-ARRAIGNMENT RELEASE PROTOCOL

#### PART I: DEFINITIONS

As used in these sections, unless the context otherwise requires:

- A. "Interview" means an investigation of a defendant for the purposes of pretrial release or pretrial supervision.
- B. "Investigation" means a Pretrial Services investigation containing CourtNet and NCIC records, charge information, personal information and demographics, probation status, address, and application of the PSA Risk Assessment (See Appendix A).
- C. "Non-Financial Uniform Schedule of Bail" means the authority granted by the court to a pretrial services specialist to apply a pre-determined release decision to detained defendants based on a uniform schedule of bail without the need for a judicial review.
- D. "Pretrial Release" means release of a defendant from custody before his or her trial date. It may be secured by any authorized method of pre-trial release including but not limited to release on personal recognizance, on nonfinancial conditions or upon execution of a bail bond. It does not include the procedure for issuance of citation as provided in KRS 431.015.

- E. "Public Safety Assessment (PSA) Risk Assessment" means the validated risk assessment tool used in Kentucky, containing questions relating to risk of flight or failure to appear and risk of anticipated criminal conduct or new criminal activity.
- F. "Risk Assessment" means an objective, research based, validated assessment tool that measures a defendant's risk of flight or failure to appear and risk of anticipated criminal conduct or new criminal activity while on pretrial release pending adjudication.
- G. "Risk scores" means the numeric values ranging from a low of 'O' to a high of '7' that relates proportionally to the defendant's likelihood of failure to appear (FTA) and from a low of 'O' to a high of '13' that relates proportionally to the defendant's likelihood of new criminal activity (NCA) pending adjudication.
- H. "Risk level" means a scale from low to high of the risk a defendant poses of pretrial failure (e.g., failing to appear or presenting a danger to the community).
- I. "Sexual Offenses" means any offense defined as sexual under Kentucky Revised Statutes and those listed by Pretrial Services as sexual for purposes of pretrial release (See Appendix A).
- J. "Verification" means matching a defendant's identity with an official record.
- K. "Verified and eligible defendant" means a defendant who is charged with a bailable offense and whose identity Pretrial Services has confirmed through investigation.
- L. "Violent Offenses" means any offense defined as violent under Kentucky Revised Statutes and those listed by Pretrial Services as violent for purposes of pretrial release under this order (See Appendix A).

## PART II: PRE-ARRAIGNMENT RELEASE PROTOCOL FOR THE PRETRIAL RISK ASSESSMENT AND NON-FINANCIAL UNIFORM SCHEDULE OF BAIL

### Section 1. Obligations of Pretrial Services and Pretrial Services Specialists

Except where explicitly noted, no provision set forth in this order shall absolve the Administrative Office of the Courts pretrial services agency and pretrial services specialists employed by the agency from following the Kentucky Rules of Criminal Procedure, including but not limited to RCr 4.02, RCr 4.06, RCr 4.08, and RCr 4.38; and the Kentucky Revised Statutes, including but not limited to KRS 431.066, KRS 431.515, and KRS 431.518; and Administrative Procedures of the Court of Justice Part XIV, Pretrial Services.

### Section 2. Risk Assessment and Risk Level

- A. All verified and eligible defendants will have their risk level assessed by use of the PSA Risk Assessment.
- B. The PSA Risk Assessment tool, once applied to a defendant, will result in the defendant's risk scores being a value between '0' and '7' for failure to appear (FTA) and between '0' and '13' for new criminal activity (NCA) with corresponding risk levels of Low (Risk), Moderate (Risk), or High (Risk) for both the FTA Scale and the NCA Scale.
- C. The Risk Assessment tool will be applied to the defendant prior to or at the approximate time of the pretrial interview. Nothing in this order shall prohibit the tool from being re-applied to the defendant at any time after the initial application.

### Section 3. Eligibility and Release Options

Defendants charged with certain non-violent/non-sexual misdemeanors or Class D felonies whose risk scores have been assessed as low or moderate risk for failure to appear and low or moderate risk for new criminal activity shall be eligible under this Schedule and shall be released on recognizance with the following exceptions:

- A. Any defendant charged with an offense listed in Appendix A is not eligible under this schedule.
- B. Any defendant charged with the misdemeanor offense of KRS 222.202 (Offenses of Alcohol Intoxication or Drinking Alcoholic Beverages in a Public Place) shall be released as follows:
  - 1. To an adult who is willing to accept responsibility for the defendant either through a signature verification on a form prescribed by the Administrative Office of the Courts or by verbal affirmation and showing a government issued identification to the jailer; or
  - 2. At such time as the defendant is able to safely care for himself or herself but in no event shall the defendant be detained for more than eight (8) hours following his or her arrest.
- C. Any defendant charged with KRS 525.100 (Public Intoxication) shall be released as follows:
  - 1. To an adult who is willing to accept responsibility for the defendant either through a signature verification on a form prescribed by the

- Administrative Office of the Courts or by verbal affirmation and showing a government issued identification to the jailer; or
- 2. At such time as the defendant is able to safely care for himself or herself but in no event shall the defendant be detained for more than twelve (12) hours following his or her arrest.
- D. Any defendant charged with KRS 189A.010 (Operating Motor Vehicle While Under the Influence 1st Offense, "DUI 1st") shall be detained for at least six (6) hours following his or her arrest.
- E. Any defendant charged with a DUI 1st offense which causes an accident resulting in death or serious physical injury as defined in KRS 500.080 is not eligible under this schedule. This provision only applies to any DUI accident where the citation indicates someone, other than a defendant, was transported to the hospital by ambulance due to the accident.
- F. Any defendant charged with a DUI 1<sup>st</sup> offense who is transporting a passenger under the age of twelve (12) years old is not eligible under this schedule.
- G. Any defendant charged with a DUI 1<sup>st</sup> offense who is not a resident of Kentucky is not eligible under this schedule.
- H. Any defendant charged with a Class D felony drug offense is not eligible under this schedule.
  - 1. Within 12 months of the date of this order, the Court will reassess the exclusion of Class D felony drug offenses under this schedule.
- I. Any defendant charged with any Class D felony who has been assessed as a moderate risk for failure to appear <u>AND</u> a moderate risk for new criminal activity is not eligible under this schedule.
- J. Any defendant charged with one of the following offenses during a natural or man-made disaster defined by KRS 500.080, or during a period of civil unrest/riot as defined by KRS 525.010, is not eligible under this schedule:
  - 1. KRS 508.025 (Assault in the third degree)
  - 2. KRS 511.040 (Burglary in the third degree)
  - 3. KRS 511.060 (Criminal Trespass in the first degree)
  - 4. KRS 511.070 (Criminal Trespass in the second degree)
  - 5. KRS 511.080 (Criminal Trespass in the third degree)
  - 6. KRS 512.020 (Criminal Mischief in the first degree)
  - 7. KRS 512.030 (Criminal Mischief in the second degree)
  - 8. KRS 512.040 (Criminal Mischief in the third degree)
  - 9. KRS 514.030 (Theft by Unlawful Taking)

- 10. KRS 514.040 (Theft by Deception)
- 11. KRS 514.110 (Receiving Stolen Property)
- 12. KRS 525.020 (Riot in the first degree)
- 13. KRS 525.030 (Riot in the second degree)
- 14. KRS 525.040 (Inciting to riot)
- K. Any Defendant charged with an offense that is punishable by a fine only (violations and traffic infractions) who has been assessed as a low, moderate, or high risk for failure to appear or for new criminal activity shall be released under this schedule; however, defendants charged with offenses of Alcohol Intoxication or Drinking Alcoholic Beverages in a Public Place shall be released in accordance with subsection B. of this Section.
- L. Any defendant charged with a crime in which there is an alleged victim(s) shall not have any contact with the alleged victim(s).
- M. Any defendant arrested for contempt of court is not eligible under this schedule.
- N. Any defendant arrested for a violation of conditions of release is not eligible under this schedule.
- O. Any defendant who is on pretrial release and has a new arrest for a new misdemeanor or felony charge is not eligible under this schedule.
- P. Any defendant who is on pretrial release and has a failure to appear on the current charge(s) is not eligible under this schedule.
- Q. Any defendant arrested on a probation violation or specialty court violation is not eligible under this schedule.
- R. Any defendant who is on active, supervised probation for a felony offense is not eligible under this schedule.
- S. Any defendant arrested on an indictment warrant is not eligible under this schedule.
- T. Any defendant charged with a crime in the Commonwealth of Kentucky and who is extradited from another state is not eligible under this schedule.
- U. Any defendant who declines the pretrial services interview is not eligible under this schedule.
- V. No defendant shall be held in custody for failure to pay the \$25.00 bond filing fee required under KRS 64.005.

W. Any defendant not eligible for release under this schedule shall only be released upon judicial review and conditions of release ordered by the court. Pretrial Services must provide the circuit judge, district judge, or trial commissioner with the pretrial risk assessment and recommendations for release within 24 hours of the defendant's booking.

### Section 4. Miscellaneous Provisions

- A. Any defendant who has an appointed guardian shall only be released under this schedule to that guardian or the guardian's designee, provided that Pretrial Services and/or the jail is made aware before release that the defendant has an appointed guardian.
- B. Any release made in error by Pretrial Services under this order shall be immediately brought to the attention of the court. Upon notice that an error was made, the court may issue a summons or warrant for the defendant's arrest or modify the conditions of release as the court deems appropriate.

This order only applies to new arrests and shall be effective June 2, 2025, and until further order of this Court.
