  - (a) One or more prior convictions of a felony criminal offense against a victim who is a minor, or
  - (b) One or more prior sex crime convictions;
- (4) Two or more felony criminal offenses against a victim who is a minor;
- (5) KRS 510.040 Rape in the first degree;
- (6) KRS 510.070 Sodomy in the first degree: or
- (7) Found to be a sexually violent predator, defined as any person who has been subjected to involuntary civil commitment as a sexually violent predator, or a similar designation, under a state, territory, or federal statutory scheme.

## 20 Year Registration - All other registrants.

### \*"Sex Crime" is defined as:

A felony offense defined in KRS Chapter 510 (Sexual Offenses), KRS 529.100 (Human trafficking involving commercial sexual activity), KRS 529.110 (Promoting human trafficking involving commercial sexual activity), KRS 530.020 (Incest), KRS 530.064 (Unlawful transaction with a minor in the first degree), KRS 531.310 (Use of a minor in a sexual performance), KRS 531.320 (Promoting a sexual performance by a minor), KRS 531.335 (Possession or viewing of matter portraying a sexual performance by a minor), KRS 531.340 (Distribution of matter portraying a sexual performance by a minor), KRS 531.365 (Possession of a child sex doll), KRS 531.367 (Importing a child sex doll), KRS 531.368 (Permitting or promoting the use of a child sex doll), KRS 531.125 (Sexual extortion), or a felony attempt of any of the above-named offenses.

### t"Criminal Offense against a Victim who is a Minor" is defined as:

KRS 509.040 (Kidnapping, except by a parent), KRS 509.020 (Unlawful imprisonment, except by a parent), a Sex Crime\* when the victim is under 18 (as defined above), KRS 531.320 (Promoting a sexual performance by a minor), KRS 531.310 (Use of a minor in a sexual performance), KRS 510.120 (Sex abuse in the second degree), KRS 529.100 (Human trafficking involving commercial sexual activity), KRS 529.110 (Promoting human trafficking involving commercial sexual activity), KRS 529.040 (Promoting prostitution when the defendant advances or profits from the prostitution of a minor), KRS 530.064 (Unlawful transaction with a minor in the first degree), KRS 510.130 (Sex abuse in the third degree), any offense involving a minor or depictions of a minor as set forth in KRS Chapter 531, or any attempt or solicitation of the above-named offenses.
