Specifically, a guardian has the power to take custody of the ward, establishing the ward's place of abode within the Commonwealth, and to take reasonable care of the ward's personal effects and finances. The proposed ward is also advised that a conservator's powers are defined in KRS 387.137 and unlike the guardian's powers, consist only of managing the ward's finances and assets.
